President's Report



On November 8th our Board of Directors approved a significant change in our organization to meet our financial crisis. In previous newsletters I've spoken of our difficulties and the possible reduction of services. In the past our organization and our numerous activities for paralyzed veterans have been significantly funded by our in-house telemarketing operation where we sell household and office supplies to individuals and businesses. These telemarketing revenues have dramatically dropped as reflected in our audited statement of activities for fiscal years 2002, 2003 and 2004. Fiscal year revenue minus expenses was a positive \$171,784 in 2002, dropped to a -\$49,008 in 2003, and further dropped to a -\$101,419 in 2004. Our fiscal year 2005 statements are currently being audited; our internal books indicate our end of fiscal year operating loss will be -\$112,313.

We have been running at a deficit monthly and have about exhausted our savings to continue to provide programs, hoping donations and telemarketing revenues would increase. As stated in the October 15th St. Louis Post Dispatch article, I said that unless we dramatically increase revenue we would no longer be able to provide all services. That crisis point came in November. The budget constraints forced us to eliminate three of our remaining four paid staff positions; in September we eliminated the Government Relations position. On November 8th we eliminated the Transportation Director, Administrative Assistant, and Development Director positions. Our transportation program, taking outpatients to activities and some board members to visit hospitalized patients, stopped pending recruiting volunteers. We are seeking help from veterans' organizations and other groups. Our plans are to add volunteer drivers to our insurance policy. In addition to transportation needs, administrative office help is desperately needed. The one paid staff position remaining is our Executive Director whose salary is 50% reimbursed from our national organization; in addition to now covering all office administrative duties, she is overseeing telemarketing.

The newspaper article quoted my belief as to the causes of decreased telemarketing revenue to include unfair competition from a terminated employee working for what has become a "competitor" charity and Missouri's expanding no-call list. As an organization we are trying to move forward in seeking new funding sources as well as ideas for fundraising activities. We are continuing to evaluate our telemarketing business. Our building is now up for sale or perhaps partial lease. There is good news to this message. With our reorganization we will finally be operating in the "black" starting December and continuing to build with a surplus each month. We will continue to furnish holiday meals and quarterly luncheons to all inpatients at Jefferson Barracks. Our special fundraising activities for the wheel-chair games and other recreation activities will begin again in the new year. And, I believe most importantly, our board members remain actively involved in ensuring member health care needs are being met.

We are one of 24 area "Honor Roll Charities" as designated by the Better Business Bureau. As reported on our last audit, 66% of what we raised actually went to programs. We do good work and account for all the funds we receive. Any assistance you might render, ideas you might have, or volunteer services you or someone you know could offer, would be welcomed. Please help us by getting involved in some way. In today's difficult climate for charities we will emerge stronger, enabling members to realize our vision of "living life to the fullest."

Not so fast. I'm back again.

I know I like to be informed about what's going on in the world as much as the next person, but sometimes I can't handle the news. It is way too depressing. So, I thought let's hear some good things. I received an ATTABOY in the mail from Phyllis Boyer, wife of PVA member Clarence Boyer. She gave me permission to share her great letter with everyone. I'm going to share it because it is very nice and pats the SCI Unit as a whole on the back.



When we come to the SCIU it's sort of like coming home. Everyone is gracious, helpful, enthusiastic and cheerful. We are always greeted very warmly. In spite of its age, the facility is always spotlessly clean with an inviting atmosphere.

The staff strives to provide any medical or durable supplies that might make life better for my husband, Clarence. Nurses, doctors and support personnel work together to compliment each other's skills and areas of expertise. Each person in the Spinal Cord Unit deserves praise and thanks for doing much more than a "job". Every individual truly makes a difference.

Clarence has been afflicted with a degenerative, progressive neuro-muscular disease for many years. He saw Dr. McGeary in his private practice for years. In January of 2000 he was hospitalized at a local hospital because of an insidious urinary tract infection. His Primary Care Physician, called on Dr. McGeary for consultation because his mobility deteriorated so rapidly. After the medical problem was cleared up, Dr. McGeary suggested a stay at Jefferson Barracks for rehabilitation. He made all the arrangements and had Clarence transferred to Jefferson Barracks.

What a pleasant surprise it was to find a not only a great medical staff, but also a wide range of related support staff. During a six-week stay at Jefferson Barracks, Clarence and myself came to consider the personnel as an extended family. At the end of six weeks a helpful seminar was presented for family members. A book entitled "Yes, you can!" was given to each participant. This book has been a frequent resource for both of us. I have even copied sections of it to share with others!

The following summer we returned several times for Clarence to receive driver's education in a vehicle equipped with hand controls. The driving instructor, a young man named Clint, subjected himself to bumpy starts, jolting stops and a few near misses in the attempt to introduce Clarence to hand controls. He deserved a purple heart for his valor.

In May of 2003 our little town of Desoto, was struck by a devastating tornado. Fortunately our home was only slightly damaged. The front porch where the wheelchair ramp was attached wasn't so lucky. It received much of the damage. This made entering and exiting dangerous. Thanks to the VA, who offered a grant to assist with repairs, he didn't remain house bound too long.

About a year ago, Clarence's mobility deteriorated to the point where he could no longer be cared for at home. He became a resident at a local long-term care facility. The facility tried to meet all of his needs but there were a few areas that were unsatisfactory.

I finally contacted Bob Sontag. He listened sympathetically and said, "we can help." Of course he knew just what to do. He scheduled a clinic appointment, notified the nursing home, arranged transportation and got the ball rolling. About a week later, Nurse Kathy made a home visit to the care facility. She implemented effective solutions to meet the most pressing problems. Thanks to the VA, his quality of life once again improved!

We are truly grateful to the VA staff for doing so much for us and for being "like family".

Sports Director's Report



Hospital Liaison's Report

We are continuing the Charter Team to continue good SCI inpatient care at John Cochran. Please get with us if you have any input. At the last meeting we emphasized issues on training and increasing staff for 6-North. Currently, all the plastic surgery is being done at St. Louis University Medical Center, many patients have procedures at St. John's MC and when emergencies arise at Building 52, inpatients are diverted to St. Anthony's MC. We will follow the care at those facilities.

A Peer Support Program has been set up. We all know part of rehab is hearing from someone that has "been there" and what to expect. Our first meeting will be held soon and we want to emphasize peer support for new injuries and some "old timers".

The VA Volunteer Services met recently and many veterans groups were concerned. In the FY budget for 2007 the gymnasium, bowling alley and swimming pool will be signed over to the cemetery division and be removed. A small swimming pool for therapy would be built but no one is sure about the gymnasium or bowling alley.

Some of the National PVA Site Visit will be in St. Louis in late January. An area that will be addressed is the SCI Center outpatient clinic. They are concerned about the outpatient clinic only available twice a week. Does this address all the needs of patients needs? Again -- how do you feel about your clinic visits?

Wheelchairs in the Media

Most recently I have both cried and laughed at the portrayal of wheelchair users in movies and on television. In early October on an episode of the HBO comedy "Curb Your Enthusiasm," the show's writer and star Larry David (original writer for "Seinfeld") tickles our funny bone and perhaps irritates some at the same time. David in other episodes pokes fun at religious and race issues and leaves us either snickering or laughing out loud. In the most recent episode David, able bodied, uses a disabled bathroom stall when others are full and upon exiting is chastised by a paraplegic waiting to use the disabled stall. Later the same day David sees a man walk out of his car in a disabled spot and David questions the man's use of the disabled spot. The man responds by saying he suffers from a stutter that qualifies him as "disabled." Under Missouri law and I suspect most states a stutter would not qualify someone for the disabled parking placard or license. Regardless, we laugh because we all know or have seen questionable disabled people jump out and briskly walk from disabled spots into a store. But while we're laughing we are also aware of the cold wintry days when we've searched in vain for a disabled spot near an entrance only to see placards that have either expired or have a few days remaining.

If you haven't seen Clint Eastwood's "Million-Dollar Baby," skip this paragraph and see the movie. If you have, you know what I'm going to talk about. Eastwood's protégé female boxer breaks her neck in an accident between rounds of a fight. We then see her life as a high-level quadriplegic in what appears to be a nice nursing home/care facility. A lot has been written about the only negative coverage of her life, including pressure sores on her legs, and the lack of any positive spin on her existence as a quadriplegic. She elicits her manager, Eastwood, to assist her in a suicide. This movie has produced a large debate in the disabled community on "assisted suicide." Likewise, the constitutionality of Oregon's assisted suicide law is now pending before the US Supreme Court. Having personally lived in the nursing home environment as a quadriplegic and also seen the end-of-life agony of some of the residents, I believe a person's rational choice to end their life should be honored. Others argue to accept that premise diminishes everyone's opinion of the disabled community, our lives are not worth the same as the able bodied. Whatever your predisposition, this movie will invoke a strong response.

Two Vietnam era movies have always come to my mind the last nine years in my wheelchair. "Coming Home" and "Born on the Fourth Of July" I believe correctly portray the challenge and struggle of wheelchair existence and yet offer hope to all of us in chairs. A rich and full life may be possible even if confined to a wheelchair is a message in both movies. In "Coming Home" the protagonist struggles with inadequate VA medical care, his opposition to the war, and a personal/sexual relationship with a woman whose husband is still on active duty. All powerful themes in this 1978 movie that could just as easily be made today. The 1989 "Born on the Fourth Of July" is accurately based on Ron Kovic's autobiography of the same title. Tom Cruise, if you can believe it, does an Oscar-nominated performance in the title role as a gung ho young Marine quickly shot in Vietnam and rendered a quadriplegic. At first he believes hard work and a positive attitude can basically overcome his physical injury. Not being able to walk again he turns to alcohol and begins to self-destruct. He gradually accepts his injury and finds fulfillment in the antiwar movement. Regardless of your opinion on the Vietnam war, both movies I believe accurately portray the difficult and successful transition of victims of traumatic spinal cord injury. From denial to depression and bitterness, to ultimate acceptance and fulfillment, is the recurring theme in both movies.

From television to the big screen, the public perception of us (wheelchair users) gets molded. Our own opinions likewise I believe can be shaped or at least challenged. My favorite portrayal is the young wheelchair-bound friend of Malcolm from the television comedy "Malcolm in the Middle." He is accepted as one of the guys, listened to because he's smart and given an extra push by his friends when there are no curb cuts. We, like everyone else, like to be recognized for what we do well and given a little help when we need it.
