VA LIFE INSURANCE DIVIDENDS

More than a million veterans are in line to share \$369 million in annual insurance dividends during 2007, according to the Department of Veterans Affairs (VA). VA operates one of the nation's largest life insurance programs, providing more than \$1 trillion in coverage to 4.5 million service members, spouses and children. The dividend payments will be sent to an estimated 1.2 million holders of VA insurance policies on the anniversary date of their policies. Sent automatically through different payment plans, the amounts will vary based on the age of the veteran, the type of insurance, and the length of time the policy has been in force. The dividends come from the earnings of a trust fund into which veterans have paid insurance premiums over the years, and are linked to returns on investments in U.S. government securities. Veterans eligible for the dividends have had VA life insurance policies in effect since they left the military and have received annual notifications from VA about the policies. Dividends are paid each year to veterans holding certain government life insurance policies and who served between 1917 and 1956.

World War II veterans holding National Service Life Insurance ("V") policies comprise the largest group receiving 2007 insurance dividend payments. They are expected to receive total payments of \$286.3 million. An additional group of World War II era veterans, those who have Veterans Reopened Insurance ("J", "JR" and "JS") policies, will in total receive dividends of \$10.1 million. Korean War era veterans who have maintained Veterans Special Life Insurance ("RS" and "W") policies can expect to receive dividends totaling \$71.6 million. Dividends totaling \$1million will be paid to veterans who served between World War I and 1940 and who hold U.S. Government Life Insurance ("K") policies. National Registry of Veterans with Amyotrophic Lateral Sclerosis (ALS) The Department of Veterans Affairs (VA) is developing a nationwide registry of veterans who have ALS, or Lou Gehrig's Disease. The goal of this registry is to collect important information for studies on the causes of ALS in veterans. In addition, the registry will provide a way for the VA to inform veterans with ALS about clinical trials and other studies for which they may be eligible.

President's Report

As I write this article at the close of 2006 I can't help but smile on the progress we've made as a chapter this year. We have expanded our programs beyond where we were when we made our budget cuts after reorganizing in November 2005. We are actually looking to expand our transportation program to Tuesdays if anyone is looking for a ride to Jefferson Barracks on that day. We also still have vacancies for providing rides on Tuesday evenings in January and February for ski lessons at the Hidden Valley ski resort near Eureka Missouri. Please contact us if



either program interests you. And while you're thinking about contacting the chapter, think about being a volunteer or getting some volunteers for us (Gateway) to host this summer's PVA Annual Convention August 12-August 18, 2007 in downtown St. Louis at the convention center. Not as large as the 2004 wheelchair games participation, but we will be expecting around 150 guests to include the Presidents and National Directors of the 34 national chapters. In December our chapter's National Director Gerald Brown tendered his resignation which was accepted by our Board of Directors. I was voted to fill the unexpired term which ends in September 2008. A few other chapters have the same individual serving as both President and National Director. Because of several of our local issues and the national convention now scheduled for St. Louis this coming summer, it's appropriate to accept the additional responsibility at this time but not something I would do on a permanent basis while serving as President. In the future I will write a separate National Director's report.

The board participated in a three-hour strategic planning session at its December 12 meeting. During our strength, weaknesses, opportunities, and threats (SWOT) analysis, the lack of participation by most of our membership again serviced. How do we get you involved? I would welcome your suggestions. Two other large issues came forward from our planning session: 1) How do we get improved medical care for our members? 2) Do we continue to lease our property after the three-year lease contract or do we buy something?

Our national organization completed a three-day site visit of the Jefferson Barracks facility and the Columbia VAMC the first week of December. The chapter listed our concerns as uneven care on the evening shift in building 52, the depletion of building 52 nursing staff by "pulling" nursing staff to other buildings, and continued unacceptable care of the spinal cord patients at John Cochran hospital to include the so-called "ambassador area" where patients may wait unattended for hours awaiting transportation. In my October message to you I mentioned I had to file a formal Freedom of Information Act request to receive the Survey of Health Expectancies of Patients (SHEP) satisfaction survey commissioned by the VA for the first and second quarters of the fiscal year (October 2005-April 2006) for our VISIN (Veterans Integrated Service Network) 15. I finally received a great deal of paperwork, took the time to sift and digest it all, and found what I consider to be some startling and disheartening, but sadly not surprising news. Within this network (VISIN 15) we have the following VA Medical Centers: Wichita (KS), Columbia (MO), Kansas City, Marion (IL), Poplar Bluff (MO), Topeka (KS), and St. Louis (John Cochran Hospital). In the category of "All Bed Sections," the St. Louis VAMC clearly had the worst scores, receiving "worse than the national average" marks in eight of the nine categories that were rated for patient satisfaction. Likewise in the "Medicine" and "Surgery" sections the St. Louis VAMC (John Cochran Hospital) had the worst marks of any VISIN 15 hospital and again rated "worse than the national average" this time in nine of the ten categories surveyed. There was a "SCI" section but not a sufficient number of responses for survey purposes. About three years ago our board conducted our own "unscientific" survey of our SCI members' experiences with John Cochran and the results were quite shocking. A "charter commission" had been formed with our participation and I do believe they tried to improve conditions for our members. If there was space available, SCI patients were supposed to be assigned to Seven North. Nurses from that area were to be cross-trained on the care of SCI patients. We are hearing that system may again be breaking down. What is a clear message from our members is that assignment to another floor or receiving services in another area of the hospital is a huge problem and is the loud message from the VA sponsored SHEP survey we finally received. Speaking for the board and as President I can tell you we will continue to pursue this most important issue.

On December 21 we hosted a holiday luncheon at the SCI center for inpatients, outpatients, families, and staff. December 28 will be our catered steak dinner for inpatients. I would encourage you at this time of the year to especially think of and pray if you feel so inclined, for all of our military personnel in harms way today. Best wishes to you and your families during this holiday season.


