28TH NATIONAL VETERANS WHEELCHAIR GAMES, OMAHA, NEBRASKA By Bobby Jackson

The 28th Annual NVWG (National Veterans Wheelchair Games) summer games in Omaha, Nebraska are just a few weeks away (July 25-29). There will be four hotels for the games this year, all within a couple blocks of the Quest Convention Center. If for some reason at the last minute you cannot go to the games, you need to make arrangements to cancel your hotel room before the games. Otherwise, you will be billed for one night's room plus tax by the National PVA. If this amount is not paid in full, you will not be able to participate in any present or future games until this has been paid. The Quest Convention Center will be used for most of the events including softball. Sled hockey will be an expedition event this year and trapshooting has been made a medal event.

Some of the expenses that you should expect are: hotel costs are \$150 a night for six nights making a total of \$900, a flight from St. Louis is \$162, and any expenses you may have for food. For those that are driving, it is 354 miles to Omaha from St. Louis and once you get there, you will have to pay \$20 a day to park your car.

TRAVELING WALL COMES TO DE SOTO, MO

A moving tribute to America's veterans was on display in De Soto, Missouri from May 8-11 at Walther Park. The Traveling Vietnam Veterans Memorial is a replica of the Wall that stands in Washington, D.C. The replica reaches more than 8 feet tall and is 370 feet long. The Memorial also includes a walk of Heroes which remembers nearly 3,000 people who died



in the September 11 terrorist attacks. Many veterans and their families attended this rare occasion. Pictured to the left: The Gateway Chapter PVA President, Stan Brown, and Board Member, Mike Norris, presented a memorial wreath during the ceremony.

MEDICAL FOSTER HOME PROGRAM

The VA Medical Center in St. Louis has been selected as one of approximately 30 VAMCs to begin a Medical Foster Home program (MFH).

This initiative is on a "fast track" to be developed and will be in operation in the next few months. A Coordinator is being hired, and will be supported by nursing, recreation therapy and occupational therapy. Home Based Primary Care (HBPC) and SCI Continuum of Care Team will both be critical parts of the program.

MFH is designed to provide a homelike environment for 1 or 2 veterans who otherwise might need to be in a skilled nursing facility. The veteran pays the caregiver \$1200 to \$2500 to provide this care, which includes room and board, 24 hour supervision, assistance with medications and whatever personal care is needed.

The homes are inspected and approved by the VAMC and the caregivers are carefully screened and monitored.

We are at this time recruiting caregivers who might like to participate in this program. Please help us spread the word.

When Amy Will told me at the swimming pool that Denny's outcome wasn't looking favorable, I blew off swimming and went to the hospital. I had a case of wishful thinking as far as Denny's condition went. I kept thinking he had been down before and he had bounced back well so many times. I saw a few of his family members at St. Louis University Hospital. One of his sisters and myself thought he'd been through a lot and this would be just a temporary down. We need your participation at these events! People that





MY NEW ROLE AT JEFFERSON BARRACKS By Fred Bradley

My function at JB is to advocate on hospital issues. Complaints regarding quality of care such as not being turned, not being bathed, not being assisted with feeding if you are unable to feed yourself, conflicts with staff, transportation concerns, delays in getting medicine or equipment, prosthetic concerns, co-payment problems, etc. This also includes patients who have gone to the John Cochran facility. In fact, I am especially interested in any problems you may have encountered during a visit or stay at the John Cochran facility.

I will do my best to resolve any hospital or care-related issues. Keep in mind that sometimes the problems can be resolved quickly, usually slowly and/or regrettably may never be resolved (an example that comes to mind is the unresolved problem of parking at the John Cochran facility).

I am also here to complete forms to file for service connection for a disability, file forms to obtain increased evaluation, file for non-service connected pension. I am here to answer questions on VA benefits.

Also keep in mind that the number one goal with the Paralyzed Veterans of America is to ensure the quality of health-care for our members & those eligible for membership who have a spinal cord injury or spinal cord dysfunction. This sometimes translates into saying that the patient must make me aware of problems as soon as possible so we can try to get them resolved. Waiting until you go home and then complain about something can be problematic, as after a long period of time, the urgency of the problem seems to decrease or is just forgotten about.

I'm still a member of the Major Medical Equipment Committee which helps insure there is a medical need for unusual or expensive equipment. I will be going to the MS Clinic at the John Cochran Division about 3 times per month.

For those of you familiar with the SCI Out-patient Clinic area, my office is down the hall toward the Crafts Room. My office is in Jim Weindel's old office in Room 2 South 25. My phone number is 314-894-6467; toll-free is 866-328-2670.

PETS FOR VETS PROGRAM THROUGH ALL PAWS RESCUE

According to a major Veterans Affairs study, 31 percent of male and 27 percent of female veterans of the Vietnam War suffered from post-traumatic stress disorder (PTSD) at some point after their return home. Symptoms of PTSD can include depression, bad dreams, irritability, and flashbacks. Many veterans from various wars are still receiving disability compensation for PTSD.

Steven Kingan of St. Louis, a disabled Vietnam veteran, knows what it's like to live with the disorder. "You can get lost in your own disability," he says. "Anything that gets you out of it is a good feeling."

Thankfully, Kingan has found something that gives him a purpose in his life—his 13-year-old white Persian cat, Polly, and his Chow/German Shepherd mix, George, also 13. Kingan adopted Polly from All Paws Rescue more than a month ago. Polly was going to be put down because senior cats have a difficult time finding forever homes. Through a mutual friend, Andrea Ohms of All Paws Rescue was able to get in contact with Kingan and give him Polly for free. Polly previously lived with a veteran who passed away. Kingan adopted George after his guardian passed away last August. He says that Polly and George get along very well.

"Steve is really good with animals," Ohms says. "He calls me every week and says he loves [Polly] to death."

After Ohms brought Polly to Kingan and saw how much the love of an animal brightened his day, they both agreed it would be a great thing to do for all veterans. Kingan was the first veteran adopter, but Ohms hopes the Pets for Vets program will grow. The program will be a way to not only help veterans, but also older and disabled pets, who would otherwise have difficulty finding a forever home.

According to Ohms, veterans interested in adopting a pet from All Paws Rescue must show proof of a military record and honorable discharge to ensure the safety of the animal. Although the pets will be free of charge, the adopting guardian must still go through an adoption process and show that he or she is capable of taking care of the animal.

Many soldiers returning home from Iraq and Afghanistan are dealing with various mental and physical disabilities that the unconditional love of a pet could ease. "If they can get this program up and going, I think it'll make a difference to the [men and women] coming home now," Kingan says.

BENEFICIARY TRAVEL BENEFITS

Benefit Description: If you meet the criteria below, you may be eligible for VA beneficiary travel benefits associated with obtaining VA health care services. In most cases, travel benefits are subject to a deductible. Deductibles **do not** apply for compensation and pension examinations and for travel by an ambulance or a specially equipped van.

You Qualify If:

- 1. you have a service-connected (SC) rating of 30 percent or more, or
- 2. you are traveling for treatment of a SC condition, or
- 3. you receive a VA pension, or
- 4. your income does not exceed the maximum annual VA pension rate, or
- 5. you are traveling for a scheduled compensation or pension examination, or
- 6. you are in an authorized Vocational Rehabilitation Program

You Qualify for Special Mode Transportation (Ambulance, wheelchair van, etc.) If:

- 1. your medical condition requires an ambulance or a specially equipped van, and
- 2. you meet one of the eligibility criteria in 1 through 4 above, and
- 3. the travel is pre-authorized (authorization is not required for emergencies if a delay would be hazardous to life or health)

Note: OEF/OIF Combat Veterans must meet one of the qualifying eligibilities or conditions noted above.

Mileage Rates:

General Travel......\$ 0.285 (28.5 cents) per mile

Scheduled appointments qualify for round-trip mileage. Unscheduled visits may be limited to return mileage only.

Deductible.....\$ 7.77 one-way (\$15.54 round trip)

- Deductible requirement is subject to a monthly cap of \$46.62. Upon reaching \$46.62 in deductibles, travel payments made for the balance of that particular month will be free of deductible charges.
- Veterans whose projected income in the year of application will not exceed the applicable VA pension rate may request a waiver from the deductible requirement.

NOTE: Mileage reimbursement claims for travel prior to February 1, 2008 will be processed at the previous rates of 11 cents per mile for travel in relation to health care and 17 cents per mile for recalls due to an insufficient lab, EKG, x-ray, etc. in relation to a Compensation and Pension examination ("Convenience of the Government") with deductibles of \$3 per one-way trip; \$6 for a round-trip; with a maximum of \$18 per calendar month.
