## **President's Report**

## **New Building**

We completed moving into our new building at 9:20 p.m. on June 11, 2010. It was almost six months to the day after we took possession. What a long and arduous challenge with contractors, inspections, and both St. Louis County and municipality code requirements. In



our last move in 2006 we really cleaned house in discarding broken furniture, unusable computers, and a mountain of paperwork/magazines that had been accumulating. This time was much different because we were fairly "lean and mean" in our possessions. In our last move, we had to pay movers twice and put the belongings in storage while our rental space was being renovated. The total moving cost was \$3,749.72. This year our Executive Director and her family, John (our driver), and me minimally by pushing boxes with my wheelchair, accomplished the move at the minimal cost of renting a U-Haul for \$113.93. Our phone numbers have not changed. The new address is 1311 Lindbergh Plaza Center, St. Louis, Missouri (63132). We'll schedule an open house soon.

## Relocation of the Spinal Cord Injury Unit to John Cochran

VA plans are still in place to build a 20-bed SCI unit at an expanded John Cochran Hospital. Board members and I have met with both Missouri and Illinois congressional leaders and staff seeking their support to stop these plans. The actual plans for a 20-bed SCI unit is contrary to published VA Planning Criteria which says a minimum of 30 beds must be built for any SCI unit. Gateway continues to oppose any SCI/D rehabilitation beds at John Cochran. We still need members to e-mail, write, or call their congressional representatives. ## **Gateway Bylaw Change to Include More Distant Board Members**

At our June 8, 2010, Board of Directors' meeting, the Board approved a bylaws change to increase the geographical diversity (non-St. Louis area) of our board membership. We have set aside two board positions for members who reside greater than 100 miles from the chapter office. These two members would be selected annually by the elected board in the fall each year beginning in 2010. They would only need to attend two board meetings in person each year and will be reimbursed reasonable expenses. Attendance by teleconference would be required for the other meetings. The text of the bylaw change is printed below. Please call our office if you are interested in being appointed; we are committed to getting new people involved from outside the immediate St. Louis area.

## Proposed Gateway PVA Bylaw Change

#### ARTICLE VII- BOARD OF DIRECTORS

Section 1: Number. The Board of Directors shall consist of no less than seven (7) and no more than thirteen (13) members, which include the officers mentioned in ARTICLE IV Section 1, the National Director to PVA, and no more than seven (7) directors to be elected by vote.

Section 2: Election. The seven (7) candidates receiving the highest number of votes shall be directors. The election process described in ARTICLE IV Section 2 shall govern the election of Directors. Two (2) additional directors shall be selected annually by the board to provide geographical distribution of its board membership. The two (2) selected board members must reside 100 miles or more from the Gateway PVA office.

Section 5: Removal. Add the following last sentence—Directors who reside greater than 100 miles from the Gateway PVA office are required to attend and be reimbursed reasonable expenses for two (2) Board of Directors' meetings in person each fiscal year, and may attend remaining meetings by teleconference.

## **VA Makes Filing Claims Easier**

VA has shortened application forms to reduce paperwork for Veterans. The new forms, which are being made available on VA's Web site at www.va.gov/vaforms <a href="http://www.va.gov/vaforms/">http://www.va.gov/vaforms/</a>; include:

- \* A shortened VA Form 21-526 for Veterans applying for the first-time to VA for disability compensation or pension benefits. This form has been cut in half from 23 to 10 pages. It is immediately available to Veterans via Web download, and will be available through VA's online claim-filing process later this summer at http://vabenefits.vba.va.gov/vonapp/main.asp
- \* VA Form 21-526b for Veterans seeking increased benefits for conditions already determined by VA to be service-connected. This new form more clearly describes the information needed to support claims for increased benefits.

In order to make the claims process faster, VA has also introduced two new forms for Veterans participating in the Department's new fully developed claim (FDC) program, which is one of the fastest means to receive a claims decision.

Gathering the information and evidence needed to support a Veteran's disability claim often takes the largest portion of the processing time. If VA receives all of the available evidence when the claim is submitted, the remaining steps in the claims-decision process can be expedited without compromising quality.

To participate in the FDC program, Veterans should complete and submit an FDC Certification and VA Form 21-526EZ, "Fully Developed Claim (Compensation)," for a compensation claim, or a VA Form 21-527EZ, "Fully Developed Claim (Pension)," for a pension claim.

The forms were designed specifically for the FDC program. These six-page application forms include notification to applicants of all information and evidence necessary to "fully develop" and substantiate their claims. With this notification, Veterans and their representatives can "fully develop" their claims before submission to VA for processing.

Along with the application and certification, Veterans must also submit all relevant and pertinent evidence to "fully develop" their claims. A claim submitted as "fully developed" may still require some additional evidence to be obtained by VA, to include certain federal records and a VA medical examination. Disability compensation is a tax-free benefit paid to a Veteran for disabilities that are a result of -- or made worse by -- injuries or diseases that happened while on active duty, active duty for training or inactive duty training. Pension is a benefit paid to wartime Veterans with limited income, and who are permanently and totally disabled or age 65 or older.

## **VA Announces Change to Medication Copays for Some Veterans**

Under the newly signed Senate Bill 1963 Caregivers and Veterans Omnibus Health Services Act of 2009 many new benefits were established. One of which is Under Title V, Section 515, the "Full Text" provides it is contained in 511.

SEC. 511. PROHIBITION ON COLLECTION OF COPAYMENTS FROM VETERANS WHO ARE CATASTROPHICALLY DISABLED.

(a) In General-Subchapter III of chapter 17 is amended by adding at the end the following new section:

'Sec. 1730A. Prohibition on collection of copayments from catastrophically disabled veterans 'Notwithstanding subsections (f) and (g) of section 1710 and section 1722A(a) of this title or any other provision of law, the Secretary may not require a veteran who is catastrophically disabled, **as defined by the Secretary**, to make any copayment for the receipt of hospital care or medical services under the laws administered by the Secretary.'.

On June 10, 2010, the Department of Veterans affairs announced that co-payments for VA medication will be increased to \$9 a prescription from the previous \$8. The really good news is that veterans that have been changed from Category 8 (income limits) to Category 4 (catastrophically disabled) will no longer have to pay co-payments for health services and medication.

The change doesn't impact Veterans in Priority Groups 2 through 6 who will continue to pay \$8 for each 30 day supply of medication for their non-service connected conditions unless otherwise exempted. These veterans will also continue to have their out-of-pocket expenses for VA outpatient medications capped at \$960 per calendar year.

Even though the increase in co-pay to \$9 has already been implemented, the "catastrophic co-pay exemption" may take up to a year to implement. Until the Secretary defines an effective date and other regulations, the VA will continue to charge co-payments.

As always, veterans who have an injury or illness connected with their military service resulting in a disability rated 50% or greater (Priority Group I) are exempt from the co-pay all together.

There are a variety of ways that you can qualify for this benefit. In order to be considered "catastrophically disabled" a veteran must have a doctor complete VA Form 10-0383. It must be submitted and approved by the Chief of Staff at the VA hospital where you are enrolled.

VHA has defined a "catastrophic disabled" veteran to be a veteran who has a permanent severely disabling injury, disorder, or disease that compromises the ability to carry out the activities of daily living to such a degree that the individual requires personal or mechanical assistance to leave home or bed or requires constant supervision to avoid physical harm to self or others.

Disabilities that are considered catastrophic are quadriplegia, paraplegia, blindness or persistent vegetative state. There is a list of other permanent disabilities that qualify, such as amputation of two limbs or dependent in three or more activities of daily living (eating, dressing, bathing, toileting, transferring, incontinence of bowel and/or bladder), or a score of ten or less under Folstein Mental State, or a score of 2 or lower on at least 4 of the 13 motor items using the Functional Independence Measure (FIM), or a score of 30 or lower using the Global Assessment of Functioning (GAF).

There are many aspects attached to Senate Bill 1963 that we will bring to you in the near future. I felt it was essential to make you aware of the co-pay exemption so that you can make sure that you have been properly categorized in the VA system as "Category 4." If you have any questions or need assistance with this process, please contact your local NSO.

## President Signs Critical Veterans Legislation into Law Caregivers and Veterans Omnibus Health Services Act

On May 5, President Obama signed into law P.L. 111-163, the "Caregivers and Veterans Omnibus Health Services Act," that will provide help to many groups of veterans including Paralyzed Veterans of America (PVA) members. PVA and other veteran service organizations strongly supported this legislation that will make an enormous difference to the recovery and rehabilitation of our injured, ill and disabled veterans and their families.

The bill was originally passed on April 21 by the House of Representatives and the following day by the United States Senate. PVA has worked tirelessly on parts of the legislation for several years. The new law covers a broad array of health-care initiatives and reforms contained in multiple bills that have been pending since the start of the 111<sup>th</sup> Congress, including a prohibition against the collection of co-payments by the VA from veterans who are catastrophically disabled. It has long been a goal of PVA to eliminate co-payments for Priority Group 4 (catastrophically disabled non-service connected) veterans. This now prohibits VA from collecting co-payments from those catastrophically disabled veterans for medical services rendered. Paralyzed Veterans' members are the highest users of VA health-care services. This important legislation will ensure that our non-service connected, catastrophically disabled veterans will continue to receive the highest quality health care without the heavy financial burden that many have faced in the past."

The new law covers a number of different areas to help our nation's veterans. In addition to the co-payment provisions, it provides help for caregivers who take care of veterans with disabilities. Many family members take care of their disabled loved ones, but never receive any training on how to properly provide the care. The new law provides training, support and in-home respite care to ease the overwhelming burden placed on caregivers of veterans. In addition, many family members give up their jobs to provide this care. Now they will have access to health care, as well as a stipend for caregivers who live with and care for seriously wounded veterans of Iraq and Afghanistan.

## Information for Veterans about Health Care Reform

Many Veterans have questions about the new health care reform law. The Veterans Health Administration (VHA) offers the following information about the law and its impact on Veterans. This document addresses only the most pressing questions that have been raised. VHA will provide additional information about the new law as it is developed.

## Impact

## Nothing in the new law changes anything about VA health care

- The law contains many complex provisions, including many reforms to the practices of the health insurance industry.
- Nothing in the new law changes anything about the Veterans' health care program.
- Enrolled Veterans may still rely on VHA for their health care in the same manner as before the law.

# Beginning in 2014, everyone will be required to have health care coverage

- The law requires that every individual must have some form of health care coverage.
- The coverage must meet a minimum standard so that everyone will be able to have a minimum level of care.
- Congress wrote into the law a provision that says the Veterans' health care program, administered by VHA, meets the standard for health care coverage.

## Enrolled Veterans do not have to purchase additional coverage

- Because the Veterans' health care program meets the standard under the law, Veterans enrolled in the VA health care program do not need to obtain additional health care coverage.
- Veterans may continue to purchase additional coverage if they wish, but the law does not require them to do so.
