

## **President's Message**

## Memorial Day - "What it's about...?"

I am writing my message about a week after Memorial Day. Seven years ago on Memorial Day, I got stuck on (broke) the antiquated chairlift ramp going from the sidewalk to the opening of the Soldiers Memorial in downtown St. Louis. About that time, I lamented on the inaccessibility of the public monument as well as the commercialization of what should be a somber holiday (Rib Fest held at the base of the Memorial and countless store sales). After a few years and a formal complaint filing with the US Department of Justice, we now have an accessible ramp for veterans to visit the Soldiers Memorial. Unfortunately, I think commercialization of the day seems even more widespread. I see less and less store closings, and those that do seem to market their patriotism by announcing their closing in advertisements stressing their altruism. News outlets continue to do three-minute segments on the ceremony at the Jefferson Barracks National Cemetery, while everyone revels in the backyard barbecue and the holiday from work. I think most people "just don't get it." In my opinion, since the ending of the draft with the Vietnam War (58,209 deaths), most Americans are unaffected by US casualties in the recent wars (Iraq-4800, Afghanistan-2229, Gulf War-258). World War II, which basically affected everyone, had 405,399 deaths. In solely my opinion, not endorsed by PVA or the Gateway Chapter, the recent war conflicts are not affecting the "haves" of our society. The majority of us are only aware of the war tolls through closing segments on the nightly news. It is not impacting us personally.

True to the stereotype, I was at a family barbecue on Memorial Day this year. There was no conversation about any family members or friends of the family that had died in recent conflicts. I, in fact, must think back to my college days when two drafted friends actually lost their lives in Vietnam. This year's Memorial Day, however, my 14-year-old nephew, who I consider relatively intelligent, asked in general to the table: "Memorial Day? Who are we memorializing?" Eyes turned to me, the only veteran at the table, as I tried to give an explanation that would endure a teenager's attention span.

I knew it was originally called Decoration Day and it was proclaimed shortly after the Civil War (625,000 deaths). I then tried to give my personal slant as a veteran in a wheelchair who "works" with many similar wheelchair veterans. As difficult as our lives may be, I explained, it does not begin to compare to those who made the ultimate sacrifice and the effect on their families. My nephew still seemed attentive as I finished, but I could tell he was done when he responded: "Oh, I didn't know that, would you pass the deviled eggs?"

The next day, the day after Memorial Day, I was more encouraged on the significance on the observance of Memorial Day. As I wheeled out of the grocery store, I passed an elderly gentleman half-leaning and half-pushing on his cart full of groceries. He was tall, thin, and moved at a slow but deliberate pace. When I got to my van, I turned and saw he was following me. I also noticed the car next to me. It had both US Army and World War II decals on the back window; the car had a Purple Heart designated Missouri license plate. Sure enough, the gentleman and his grocery cart arrived at the same time at that car. After he finished loading his groceries, I rolled close to him, knowing I am soft spoken and suspecting he was hard of hearing, and spoke as loud as I could: "You're an US Army veteran who was in World War II?" He smiled, showing a full set of



white teeth and twinkling eyes. He told me he indeed was in the Army and that he had been an infantryman in Germany in the waning years of the War. I then asked him how he had received his Purple Heart and what campaigns or battles he experienced. Then, for the next ten minutes, in the hot sun, he regaled me with his experiences and pointed to the three places on his body where he had received shrapnel. I thanked him for his service and for sharing his experiences with me. He smiled again and told me there were fewer and fewer World War II veterans. I told him I knew that and he then closed by saying: "Although I am now 97, and fewer of us are around, I still remember the name of every friend of mine who died over there."

## Senator McCaskill VA Health Care Survey—By Stanley Brown

I think it has gone below my radar, although I know it started in 2011 when there were sterilization issues at John Cochran, but for the past three years, Missouri Senator Claire McCaskill has been administering an online survey for veterans using Missouri VA facilities. The VA also annually contracts with a private group to administer the Consumer Assessment of Health Care Provider Systems (CAHPS), which replaced the old SHEP survey. Both instruments gather data from mail surveys sent to veterans using VA facilities. Senator McCaskill is also trying to gauge VA performance and address problems that veterans bring forth. In addition to answering VA CAHPS survey questionnaires when you receive them, I would encourage you to visit Senator McCaskill's website (http://www.mccaskill.senate.gov/) to record your VA experience. You can take the survey directly (http://www.mccaskill.senate.gov/vcsp/). ## **VA Fully Developed Claims**

Veterans, Servicemembers, and survivors simply submit the application form with all relevant records in their possession, and those records which are easily obtainable, such as private medical records, at the time they make their claim and certify that they have no further evidence to submit. The VA can then review and process the claim more quickly.

If a Veteran is filing a VA claim for the very first time, it is an original claim. A reopened claim means the Veteran has new and material evidence and wants the VA to reconsider a claim it once denied. There are also new claims, secondary claims, and special claims.

Veterans may file a FDC for disability compensation for an injury, disability, or condition believed to have occurred or been aggravated by military service, or for a condition caused or aggravated by an existing service related condition. By filing an FDC, Veterans, Service members and survivors take charge of their own claim by providing all the evidence at once. By then certifying that there is no more evidence, the VA can issue a decision faster.

Participation will not affect the attention the claim receives from qualified VA rating staff or the benefits to which the Veteran is entitled. If the VA determines other records exist and those records are required to make a decision on a claim, the VA will simply remove the claim from the FDC program and process it through the traditional claims process. Once a Veteran initiates a FDC, he/she will have up to one year to complete it. Should the VA approve the claim, benefits are to be paid back to the day the claim was initiated. Though the VA is attempting to make disability claim filing as easy as filing a tax return through H&R Block's automated website, it is highly recommended that before filing an electronic claim, you consult with your friendly neighborhood PVA NSO. It is imperative that the Veteran has a good understanding of the difference between claims for service connected and non-service connected conditions, eligibility for ancillary benefits, the five types of service connection, the eligibility requirements and household income relevance for non-service connected disability claims, and the application of each of these to the Federal Law and Regulations that govern Veteran Benefits.

Veterans who disregard counsel with their NSOs prior to submitting FDCs through eBenefits are requested to give their NSOs a courtesy "heads up" that the claim has been submitted for tracking purposes. Service Officers' contact information can be found on page 2.
