PVA National Resolution for eligible members with MS

A new resolution at the May PVA National Convention voted to expand membership to include all Veterans with a Multiple Sclerosis diagnosis. Up until now, only veterans living with MS that were affected by bowel and bladder issues, mobility issues, and spinal cord involvement, were eligible to become a member. Now all veterans living with MS are eligible to join the PVA, no matter what the progression of their disease is. National PVA has formed a committee committed to serving veterans with MS. Every PVA Chapter has a representative that reports to this new MS Committee.

Interim Final Rule-Presumptive Service Connection for Rare Respiratory

Cancers Due to Exposure to Fine Particulate Matter

The Department of Veterans Affairs (VA) announced the addition of nine rare respiratory cancers to the list of conditions presumed to be service-connected due to military environmental exposure to fine particulate matter.

VA determined through a focused review of scientific and medical evidence there is biological plausibility between airborne hazards, specifically particulate matter, and carcinogenesis of the respiratory tract, and that the unique circumstances of these rare cancers warrant a presumption of service connection.

Based on these findings, VA published an interim final rule establishing presumptions of service connection for several rare respiratory cancers for certain Veterans.

These cancers include:

- Squamous cell carcinoma of the larynx;
- Squamous cell carcinoma of the trachea;
- Adenocarcinoma of the trachea;
- Salivary gland-type tumors of the trachea;
- Aden squamous carcinoma of the lung;
- Large cell carcinoma of the lung;
- Salivary gland-type tumors of the lung;Sarcomatoid carcinoma of the lung; and

• Typical and atypical carcinoid of the lung.

The rarity and severity of these illnesses, and the reality that these conditions present a situation where it prompted us to take action. We are utilizing a new approach, one that takes all available science into account, with one goal in mind—getting today's Veterans—and Veterans in the decades ahead—the benefits they deserve, as fast as possible. We are fulfilling our promises to provide more care, more benefits and more services to more Veterans than ever before.

VA focused its rule on the rare respiratory cancers above for Veterans who served any amount of time in the Southwest Asia theater of operations and other locations. VA invited and will consider public comments as part of this process.

I needed the serene time to calm down and gather my thoughts and feelings after such a significant loss. Long story short; you need two working rods. The only two in my garage were a regular size one and a toddlers Scoop Doo rod, which happened to be my dearly departed Jackson's.

I caught 21 fish that first day. Granted most were little, but in this competition it's not a huge deal breaker. They needed to be at least four inches long. LaRoy Smith and I took second or third in the team competition the next day. I honestly don't recall what was won that day, but it was a still quite the surprise. It was all good, but my next fishing experience was the bomb!

Now to the present Kentucky Lake awesomeness:

I, of course, bring my Scooby with my Zebco Dock Demon. I primarily use Scooby because it's usually little fish right off the dock or at least I thought. I use short rods because I have messed up shoulders, and of the good karma my nephew gives me. It's just entirely a sentimental issue for me to use his Scooby pole. This whole thing kind of blows my mind. I caught 21 fish the first day once again. There is a limit, but 21 was personal. At the end of the day the officials weigh the heaviest of ten; ka-ching, I won \$500.00! I also won a nice award shaped like a fish and a beautiful new fishing rod. Not too shabby for unskilled fisherman.

The second day was team day. We drew numbers out of a hat earlier. I got paired up with Michael Murphy from Kentucky. As luck would have it, I have known him for many years. He was a spinal cord patient at Jefferson Barracks back in the day. I considered myself lucky because he was from Kentucky and I have heard through the gossip he always done well. Well, here we are on beautiful Kentucky lake with the extreme wind and hot sun when

it was out it wasn't bad, but then when sun disappeared behind a cloud it was chilly.

Fishing on the one side of the dock was dead after awhile so I suggested to move to the other side. It took about 30 seconds to cast and - bam - a fish. Then another, then of course more dead time. I stayed in the spot and persevered. Patience is a virtue. It's important in this kind of an event. Back to catching a few more. Cast it out again and a bit later I asked the volunteer if the line was tangled? It's heavy. The volunteer said no, hold on, do not pull he ran down borrowed a net, came back and scooped out of the water a 2 lb 17 oz catfish using a toddlers Scooby Doo Amazing the line didn't break. 76th Annual Convention 17-21 May 2021 Atlanta GA

I delivered the Stan Brown Memorial edition of the Gateway Gazette to National Vice President, Hack Albertson. On Thursday we wore bowties and the Gazette was given to each National Director. All had good things to say about Stan. He was one of a kind and had a positive impact at National. Following are some of the highlights from the Convention.

First day of Convention (Tuesday)

Welcoming remarks by National PVA President Brown, Call to Order, Certification of National Directors, and Report of Code of Ethics. We then heard from each member of the Executive Committee.

Received a sheet on FY21 Chapter Financial Data. I was surprised to see how well Chapters were doing. Of the 33 chapters, 20 had Net Assets over \$1 million dollars. Four had a balance of \$400,000 or less. High was \$3,440,000 and low was \$104,000. Four had an Expense Ratio of 90% or above. High was 95% and low was 57%. Nationals target is 65%.

Several Resolutions were presented and voted upon:

Resolution was presented to allow veterans with ALS to be fast tracked into PVA membership. This resolution passed.

Mountain States National Director Izzy Abbass and 21 other National Directors presented a resolution to change one of the award categories from the John M. Price award to the Stanley D. Brown Most Improved Chapter award. This award category will begin in 2023.

National Executive Director Carl Blake, and the Director of Communications Liz Deakin provided a presentation on PVA branding. ALL of us contribute to how we are perceived. That means all the way from National level, to Chapter level, down to the individual. It all impacts how we are perceived and how others see us!

The DRTV Program is designed to provide this information. In order to make this program self-sustaining for the new projections, it will take a minimum of an additional \$5,000,000 over and above the \$7,000,000 already earmarked for the program.

DRTV Goals

More revenue diversification and growth. More sustainers for a predictable revenue stream. Increase PVA awareness:

- a) Among Veteran Service Organizations (VSO) donors, PVA Brand awareness is between 1% - 3% b) Currently PVA is last in recognition behind WWP, DAV, VFW, USO, Amer Legion, AmVets.
- c) Among VSO donors who are familiar with PVA, we are their last choice to give a donation to, and this remains the same across all age groups. d) Only 2% 4% of VSO donors who are familiar with PVA would donate to PVA first.

Lack of Awareness = Distrust. Under Charity Navigator PVA is 2 stars out of 4 stars. Charity Navigator believes donors can give with confidence to charities with a 3 or 4 star rating.

With PVA 67% goes to Veterans and 33% goes to administrative costs, including staff salaries, and fundraising costs.

After much discussion it was decided that our star rating needed to be upgraded if we are to be considered favorably. DRTV group also is looking to increase television advertisements with some big star endorsements.

Need to expand our donor list. More individual monthly donors, more annual corporate sponsors, etc. The DRTV program was approved with additional funding. The Board of Directors will get regular updates at each Convention.

STRATEGIC PLAN

The board was presented with a five year Strategic Plan developed by Wellspring Consulting. PVA has never had a strategic plan. Also provided was a Governance Recommendations (THOUGHT STARTERS FOR FUTURE CONSIDERATION). This plan would:

Provides a road map for PVA over the next five years. Outlines strategic goals and processes to attain them. Change to PVA's organizational structure to support this work, etc.

Will be reviewed annually to determine how we're doing and what needs to change.

After much discussion, approval was granted to move forward.

It was mentioned that the National PVA has difficulty passing on national information to members. It's important that they have valid contact information. E-mail addresses and telephone numbers.

The FY 2022 budget contains a 3.9 % increase to help with inflation. New National Grant is \$12,555 a month or \$150,655 a year.

Making Memories at Field of Dreams


Approximately two years ago during the VVC connect meeting we started tossing around ideas about things to do when life got back to normal. We wanted to incorporate a location that was equal drive for the Kansas City side of the state and the St. Louis side. I started googling locations and came up with what I felt might be the perfect place. That place was the movie site for Field of Dreams, plus some dining experiences in the city of Dubuque, Iowa. Dubuque is only about a thirty minute drive from the Field of Dreams movie site. Charlie Wright Recreation Therapist for the VA Jefferson Barracks was all for the idea so we started to run with it. I contacted the travel bureau for Dubuque, got connected with a lady named Becky Carkeek. I informed Becky that we would be a group of wheelchair-bound paralyzed veterans and need accommodations plus dining options that would be fully accessible. This lady is a saint, she prepared the itineraries with times plus travel to get us to the next destination perfectly. She negotiated a discount rate at the hotel, and made reservations at all the venues we attended. She was the true hero in this trip.

Now for some of the highlights of the trip, the important stuff. We all arrived approximately the same time from each area of the state. We checked in at the Holiday Inn Dubuque right downtown. It's a beautiful hotel. The only negative was this weekend was filled with what looks like 11 and 12 year old boys for a baseball tournament. The hotel was completely sold out. After checking in and unpacking, we headed to our first destination dining venue. The restaurant named appropriately Catfish Charlie's, set on an island in the Mississippi River. When we arrived there was a line out the door to get in but because of our travel pro Becky, we were whisked right to the front of the line and taken into our own private dining room all set up and ready to go. We ate a wonderful meal, enjoyed each other's company and got to meet each other personally most of us for the first time. After dinner and the long day we all retreated back to our rooms to get some much-needed rest and prepare for the next fun filled day.

The next morning some of us gathered in the hotel restaurant for breakfast discussing our fun plans for the day. Everyone is excited to head to the Field of Dreams movie site. We had six veterans plus the caretakers, so we had several different vehicles. We all caravan in a row headed out to Field of Dreams. And our tour professional Becky had also arranged for a ghost player to spend time with us and

explain the history of the area. When we arrived it is exactly the same as displayed in the movie. The house is the same the field is exactly the same. Mostly people come from all over the world and are continually playing games on the field. It truly lives the saying if you build it they will come because to this day they still come and they still play. After visiting in the gift shop we decided to venture over towards the field and lo and behold as soon as we left the gift shop the ghost player was waiting for us. His name is Chad and he was an incredibly professional. He even stated he would stay with us all day if we needed. And he informed us it was his honor to help and be of service to the veterans in our group. He went over the history of the movie site and details about the movie and of course took photos with all of us. The most magical moment at that site to me was before we left the field. I hope you can picture this but on the first base side of the field there were a group of younger girl softball players tossing the ball along the side of the diamond. On the third base side they were a group of boys approximately the same age 12-14 maybe younger tossing the ball around. I spoke over to Lou Monken that we should take a lap around the bases in our power chairs,

I would like to share some updates on our wonderful SCI/D Aquatics programming. If you haven't been here in a while, the home base for our aquatics program is now next door to Building 52 in Building 54. It is a beautiful new pool, equipped with a lift and ramp access. There is also a changing room that has a roll-in shower, height adjustable changing table, and overhead lift to access both changing table

> SCI Therapy has slotted times in the pool on Monday, Wednesday and Friday afternoons. All therapy staff can and have used the pool with SCI veterans for SCI PT, OT and Rec Therapy sessions. Some of the sessions are scheduled for the purpose of skilled therapy inpatient and outpatient treatment sessions, and many sessions are used for the purpose of

wellness programming.

What are the benefits of aquatic therapy? There are many! Some benefits include the buoyancy of water allowing more freedom of movement after SCI. It may help with spasticity management and pain management. The pool can also be used for cardiovascular exercise.

Medical clearance is required prior to participation in VA SCI aquatics programming. If you are interested in learning more about aquatics programming, please contact Charley Wright or Matt Luitjohan at 314-652-4100, ext 64590 or 66602.

Is JB too far for you? Don't give up on considering aquatics to meet your health and wellness goals! It may be more feasible to explore a community pool that is closer to your home, and our SCI Therapists can still help! We can talk with you about accessibility items to consider when touring local pools. Our therapists have even done site visits with veterans to community centers, when it is within reasonable distance from JB. If you are outside reasonable range- we can certainly use virtual technology to assist you. Once you have identified a local aquatic center that will meet your needs- we can discuss programming to meet your goals.



What is Indego?

A robotic device that enables veterans to walk again.

Indego is an FDA-approved exoskeleton worn around the waist and legs that enables individuals paralyzed from spinal cord injuries to stand and walk, offering a new level of independence.
