SPORTS POINTS GIFT CARDS

We have reached the end of the fiscal year and it is time to redeem your accumulated Sports Points for gift cards of your choosing. Gift card usage will be awarded at \$1 per point earned, up to \$300 annually and only awarded in a non-cash distribution such as gift cards or event tickets and you must have accumulated a minimum of 25 points to receive a gift card. All points to be used for gift cards must be redeemed by August 31 of this year. Please call or email Amber or Chris to determine your sports points accumulation this year and to let us know what type(s) of gift cards and the amounts to be applied to each type of card.

If you want to redeem your points for a Visa gift card, 5 points (\$5) will be deducted from you total to pay for the activation fee.

Remember that if you have used or plan to use your sports points for athletic events such as the Winter Sports Clinic, National Veterans Wheelchair Games, Trout Lodge or any other event, you may not use your remaining sports points for gift cards.

GENERATOR GRANT CHANGE

The Gateway Chapter has many grants available to its members that we have written about in past newsletters. As of the May 2023 Board of Directors meeting, there has been a slight change to the availability of the Generator Grant starting in FY24 (July 1, 2023).

As it was at the inception of the generator grant, this will only be available once a year and in a limited amount. Fortunately, the Chapter was able to provide this grant all year round for the last few years and in an unlimited capacity.

To stay fiscally responsible, the Chapter Board has decided to go back to opening the grant around October which will be announced in the September/October issue of the newsletter.

All other membership grants remain the same and are also listed below for reference:

- ⊳Home Accessibility Grant open year round
- ⊳Hand Control Grant open year round
- ► Accessible Vehicle Grant once per year, typically during summer

NATIONAL DIRECTOR REPORT

The first day of the convention dealt with welcoming remarks by President Charles Brown. Then the Executive Director Carl Blake gave a report which was then followed by the remaining members of the executive committee. That included Secretary Marcus Murray, Treasurer Tom Wheaton, Sr Vice President Robert Thomas and Vice Presidents Tammy Jones, Hack Albertson, and Josue Cordova. Some of the highlights:

End of April National had approximately \$1,100,000 in Checking; Operating Reserve \$18,400,000 and Board of Directors Designated \$60,900,000 for a total of \$86,400,000. PVA remains solvent, but needs to make some corrections to show they are good stewards of their money.

PVA National Budget.

FY24 is going to be a rebuilding year. National PVA hired an analytic firm to conduct a study to determine what we were doing wrong, and what we were doing right, big outcome was with the Direct Mail Campaign. We were spending far too much money with a very low rate of return. More funding needs to go into Digital mail.

We were provided a chart that listed each Chapters Revenue versus Expenses. Sixteen chapters spent more than revenue received. We were in that category with \$45,437 Gateways contributions to national for PVA Research, Education, and Clinical Practice Guidelines with \$1,000 to each program. We were right in the middle. Low was \$500 to a high of \$10,000.

Several Resolutions were presented and passed. (1) Change in title of Executive Director to Chief Operating Officer (2) change title of President to Chairman of the Board, and Secretary at National Service Officer locations to Administrative Assistant. (3) Revised National take on Sexual Harassment. National is very serious on this subject and it will not be tolerated. (4) Increased Attendant Pay from \$120 to \$130 a day. (5) Stated a program for victims of National Disaster. They will issue you a grant of up to \$1,500. (6) Changed the Chapter end of year reporting requirements to a date within 135 days of the close of the Chapters Fiscal Year.

Issued (5) Speedy Awards: Member Category: Craig Enenbach; Non -Member Category: Dr Stephan Waxman, and Dr Paul Gorman. Posthumous Category: Fred Cowell and Kenneth "Ken) Klein.
