REPORT OF SENIOR BENEFITS SPECIALIST

The Pact Act

The PACT Act is a new law that expands VA health care and benefits for Veterans exposed to burn pits, Agent Orange, and other toxic substances.

The PACT Act adds to the list of health conditions that VA will assume (or "presume") are caused by exposure to these substances. This law helps VA provide generations of Veterans—and their survivors—with the care and benefits they've earned and deserve.

The PACT Act will bring these changes:

•Expands and extends eligibility for VA health care for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War, and post-9/11 eras

•Adds 20+ more presumptive conditions for burn pits, Agent Orange, and other toxic exposures

•Adds more presumptive-exposure locations for Agent Orange and radiation

•Requires VA to provide a toxic exposure screening to every Veteran enrolled in VA health care

•Helps us improve research, staff education, and treatment related to toxic exposures

VA has added more than 20 burn pit and other toxic exposure presumptive conditions based on the PACT Act. This change expands benefits for Gulf War era and post-9/11 Veterans.

These cancers are now presumptive:

•Brain cancer

- •Gastrointestinal cancer of any type
- •Glioblastoma
- •Head cancer of any type
- Kidney cancer
- •Lymphatic cancer of any type
- •Lymphoma of any type
- •Melanoma
- •Neck cancer of any type
- Pancreatic cancer
- •Reproductive cancer of any type
- •Respiratory (breathing-related cancer of any type

These illnesses are now presumptive:

- •Asthma that was diagnosed after service
- •Chronic bronchitis
- •Chronic obstructive pulmonary disease (COPD)
- •Chronic rhinitis
- •Chronic sinusitis
- •Constrictive bronchiolitis or obliterative bronchiolitis
- •Emphysema
- •Granulomatous disease
- •Interstitial lung disease (ILD)
- •Pleuritis
- •Pulmonary fibrosis
- •Sarcoidosis

Based on the PACT Act, VA has added 2 new Agent Orange presumptive conditions:

- •High blood pressure (also called hypertension)
- •Monoclonal gammopathy of undetermined significance (MGUS)

Toxic exposure screenings are available at VA health facilities across the country.

Every Veteran enrolled in VA health

care will receive an initial screening and a follow-up screening at least once every 5 years. Veterans who are not enrolled and who meet eligibility requirements will have an opportunity to enroll and receive the screening.

The screening will ask you if you think you were exposed to any of these hazards while serving:

- •Open burn pits and other airborne hazards
- •Gulf War-related exposures
- •Agent Orange
- Radiation
- •Camp Lejeune contaminated water exposure
- Other exposures

VA will then give you information about any benefits, registry exams, and clinical resources you may need.

Ask about the screening at your next VA health care appointment. If you don't have an upcoming appointment, or if you want to get the screening sooner, contact your local VA health facility. Ask to get screened by the toxic exposure screening navigator.

Ask your local PVA service officer for assistance in filing any new claims with VA. PVA NSOs will work with you to get the benefits you are entitled to due to your exposure.





I would like to focus on the topic of mental health this newsletter. It's a hot topic in today's world, and I believe we have improved awareness that this is an extremely important part of our health and wellness.

Here at St. Louis SCI/D Center, we are grateful to have amazing professional support programs in place, primarily led by our SCI/D psychologists, chaplains, and social workers. Since the pandemic, much of our inperson programming was put on pause. Some programs switched to virtual options, and some were temporarily suspended. Our Rec Therapy community integration programming was put on pause during the pandemic, and recently restarted with some modifications.

> For those of you that completed your SCI/D rehabilitation during the pandemic, we know you missed some of these essential components of SCI/D rehabilitation. I have worked for the VA for over 20 years, and I am completely awestruck and humbled by the support you provide one another through your military camaraderie and SCI/D experience. It is something that is so awesome and do not see in any other hospital, I believe.

> > I want to highlight some of our formal programming to support your mental health. Our wonderful SCI/D Chaplain Wayne-Lupkey leads a SCI/D Caregiver Support Group. Caregivers- we recognize that you are an essential


part of our SCI/D veterans' healthcare! This support group provides SCI/D caregivers an opportunity to meet and support each other in a group setting, as well as to learn and experience a variety of self-care and wellness strategies to improve personal well-being. This group also provides information about caring for your SCI/D veteran. There are both in-person and virtual options for participation. This group meets the first and third Wednesday of the month, 2-3pm Central time. We are also in the process of reviving our SCI/D Peer Mentor program, thanks to the outstanding leadership of Dr. Alvarez. This program will have both in-person and virtual options. Peer mentoring is a one-to-one relationship between someone who has successfully coped with SCI/D and someone trying to cope with it. Mentoring provides confidential, consistent commitment to someone in need. There is a process and training required to become a SCI/D Peer Mentor. There is great value in working with a mentor, whether you have a new injury, or have new challenges with an older injury. You also have a unique perspective and insight to share with others. Please let us know if we can help you in this area. If you are interesting in being a Peer Mentor or have interest in being contacted by a SCI/D veteran mentor, please contact Alex Alvarez, PhD, 314-652-4100, ext 63179, for more information.

Finally, we have an excellent SCI/D Recreation Therapy staff that can help you with goals of increasing your activities in the community. While we all took a step back during the pandemic, our SCI/D Rec Therapy staff can help you with a personalized plan to increase your engagement in community activities.
