

The Gateway PVA Board of Directors recently awarded the Fisher House Foundation \$5000 towards establishing a "home away from home" for families of patients receiving medical care at Jefferson Barracks VAMC. This home will be located within walking distance of the medical center. There are currently 37 Fisher Houses, with four more in construction or design, and the St. Louis facility in the fundraising phase. The \$5000 will go towards the 50% that the St. Louis VA will contribute to make the Fisher house a reality. The Fisher House foundation will raise the other 50%. Fisher Houses<sup>TM</sup> are given to the U.S. Government as gifts. Military service secretaries and the Secretary of Veterans Affairs are responsible for the operation and maintenance of the homes. The Fisher House<sup>TM</sup> Foundation, Inc., a not-for-profit organization under section 501(c)(3) of the IRS code, builds new houses, and assists in the coordination of private support and encourages public support for the homes. Typically, the houses are 5,000+ to 16,000 square foot homes continued in right column

donated by the Fisher family and Fisher House<sup>TM</sup> Foundation. Each house is designed to provide eight to 21 suites. All are professionally furnished and decorated in the tone and style of the local region. The houses can accommodate 16 to 42 family members. They feature a common kitchen, laundry facilities, spacious dining room and an inviting living room with library, and toys for children. A Fisher House<sup>TM</sup> is a temporary residence and is not a treatment facility, hospice or counseling center. The program began in 1990, and has offered more than TWO million days of lodging to more than 110,000 families.

### PARALYZED VETERANS OF AMERICA EDUCATIONAL SCHOLARSHIP PROGRAM

The Paralyzed Veterans of America's primary goal has been to assist its members and their families in improving the quality of their lives. This goal has been addressed through a variety of activities, including the establishment of the Educational Scholarship Program. This program assists PVA members and their immediate family members by funding a post-secondary education.

### **Eligibility**

- · Applicant must be either a PVA member, the spouse of a PVA member, or an unmarried child (under 24 years of age) who is dependent (as defined by the IRS) on the member for principal support.
- · Applicant must be a citizen of the United States.
- · Applicant must be accepted or enrolled as a full-time or part-time student in an accredited US college or university.
- · Past award recipients may apply.

### **Award Amounts**

PVA will award scholarships in the amount of \$1,000 to full-time students and \$500 to part-time students. Scholarship funds are released solely in the name of the university. Under no circumstances will payment be made to the students.

### **Application Submission**

All components of the application must be received by **June 1, 2007**. Late applications will not be accepted, no exceptions. In addition, a ny incomplete applications will not be considered. The components of the applications should be clipped, not stapled or bound. 

# **President's Report**

### The Elephant in the Dining Room

The family begins their Sunday dinner with an uninvited guest at the table. A 2000 pound elephant is positioned at one end of the large dining room table. All family members discreetly look at the elephant, make no comment, and proceed to eat dinner. A normal dinner



This story reminds me of the problems with VA health care at John Cochran Hospital for our paralyzed members and I believe other veterans accessing that hospital. It's the elephant no one acknowledges. Recent headlines concerning VA care at Walter Reed Hospital prompted tours from Congressman Russ Carnahan at Jefferson Barracks, Congressman Lacy Clay at John Cochran Hospital, and Senator Christopher Bond also at John Cochran. I wrote to all three men about our concerns and met with their St. Louis office representatives prior to their visit. I expressed our organization's concern with our members not being properly treated at John Cochran. During their visits, the Senator and Congressmen were quickly enveloped with an entourage of VA officials and guided through their visit. On the scheduled visits we saw polished floors and made our entrance through the newly refurbished south side of the building. The main entrance on Grand Boulevard, with its deteriorating parking lot and overcrowded entry foyer, was avoided. Whenever given the opportunity, I expressed my concern over the care of our paralyzed veterans who had to endure stays at John Cochran Hospital. At an October 2002, National PVA site visit, our Chapter went on record as saying that "John Cochran absolutely fails with regard to SCI/D patient care." In September 2003, our Gateway Chapter surveyed our membership about their care at John Cochran Hospital and received horrifying results of people not being fed and lying in waste. In response, the Medical Center formed a "Charter Committee" to improve the care. The Six North section of the hospital was also planned to be designated for spinal cord patients. Neither the committee nor VA management ever approved and permanently implemented an instrument to measure improvements in spinal cord patients' treatment at John Cochran Hospital. At our February 2005, PVA site visit, our Chapter commented that we thought patient care had improved from the anecdotal reports we had been receiving. There was, however, to our knowledge no patient satisfaction survey or other instrument to measure quality of care.

In 2006, the Chapter began to hear increased complaints from our members about their treatment at John Cochran Hospital, especially from patients who had to spend time in areas other than Six North. In the fall of 2006, one of our Kansas City members mentioned a VA patient satisfaction survey he had received concerning the VA Hospital in Kansas City, which is like St. Louis and part of Veterans Integrated Service Network (VISN) 15. As President, I immediately verbally requested a copy of the survey from management at the St. Louis VA Medical Center. I was told I had to formally submit a Freedom of Information Act (FOIA) request and did so on October 4, 2006. Although the request was initially lost, I finally received from the VISN 15 FOIA Officer, a copy of an independent VA study entitled "Survey of Health Expectancies of Patients" (SHEP). The survey covered the first two quarters of fiscal year 2006 (October 2005-March 2006). On February 14, 2007, I filed another written request for a copy of the third and fourth quarters of fiscal year 2006. On March 6, 2007, not having received the report, I made a phone call and was told, "they were working on it." The second six months' (April 2006-October 2006) survey was received and the disgraceful results were similar to the first six months. The SHEP survey is based upon June 27, 2006, VHA Directive 2006-041. The Directive says the VA mission is to provide "patient-centered healthcare," and that it is essential "that veteran patients view VA as the best place to receive their health care and that VHA becomes their provider of choice." The Directive further sets forth 13 areas of patient satisfaction for standards. The SHEP satisfaction survey is administered in all 23 VISNs. The St. Louis VAMC, John Cochran Hospital, is one of seven medical centers in VISN 15. The other hospitals are in Kansas City, Wichita, Columbia, Marion, IL, Poplar Bluff, and Topeka, KS. The St. Louis satisfaction scores were clearly the worst of any of the seven hospitals. Responses are statistically analyzed and some scores are considered "significantly better" or "significantly worse" than the average for all the VA hospitals. In the categories of All Bed Sections, Medicine, and Surgery, John Cochran Hospital fiscal year 2006 patient satisfaction survey responses were "significantly worse than the national average" 80%-90% of the

During Senator Bond's visit, everyone gathered in a conference room at John Cochran prior to the scheduled tour. In a room of about 30, Bob Larkin and I were the only disabled VA patients in the room. When asked about our concerns, I detailed the shameful SHEP survey results and said it was clear that if a veteran had a choice, they would not receive care at the St. Louis VA Hospital. I further said that I knew many paralyzed veterans who are actually afraid to receive treatment at John Cochran Hospital. I did acknowledge that our organization felt some improvements had been made on Six North, at least on one shift, and that we had favorable reports on some specialized areas like nuclear medicine, but our paralyzed members continue to not receive adequate care in the rest of the hospital. After my comments there was of course a deafening silence. Someone had mentioned the presence of the elephant at the dining room table. The Medical Center Director responded that they were working on improving the satisfaction survey scores and that the VISN Director had told him two things: The low scores were not that significantly different from other scores, and urban hospitals tend to have low scores. Not wanting to be too argumentative, I didn't respond. The excuses are without merit. That designation that some results are "significantly worse than the national average," is the VA's own statistical determination and I don't see how we can question it. Secondly, the assertion that all VA urban hospitals have low satisfaction scores is of little consolation to the St. Louis veteran who must access John Cochran Hospital. Since that response, I made another FOIA request in writing on April 2, 2007, to receive the survey responses from all 23 VISNs. Let's verify the claim that all urban hospitals have low scores. On April 13, 2007, not having received an acknowledgment of my request, I called and left a message. As I finish this article on April 23, 2007, I still have no response. Although I've yet to convince any Congressional people, I'm personally of the opinion that only outside-VA intervention can change the culture at John Cochran which is reflected in the shameful satisfaction survey results. Many of our old-timers tell me that it's "been that way forever and you're not going to change it." Regardless, our Gateway chapter is going to talk about this "elephant at the dining room table" to anyone who will listen.

# **National Director's Report**

GENTLEMEN and LADIES-start your engines! On April 17, 2007, the National Board of Directors for PVA voted to be a primary sponsor for at least eight races of a Dodge in the 2007/2008 NASCAR race season. The official contract was signed on April 23, 2007. PVA signed an agreement with the BAM racing organization to sponsor their car number 49 (Driver Mike Bliss), which means the PVA logo will be placed prominently on at least the



hood and panels of the car and we will be able to do other promotions and marketing in connection with the car and the races. There are 30 races each season and PVA will be the Primary Sponsor for at least six (6) of these each season and an Associate Sponsor for the remainder of the races (opportunities exist to upgrade to the Primary level throughout the seasons).

Our meeting on the 17th started at 9 a.m. and stretched into the early evening. Initially we received considerable information on the NASCAR market of 75 million fans. The goal of our involvement was set forth to leverage PVA sponsorship of a NASCAR vehicle to increase awareness, enlarge our donor base, and generate revenues. In addition to our logo on the car, we will be looking for additional races or season sponsors and supporters for displays on the vehicle. The marketing of PVA/NASCAR merchandise as well as PVA track presence at the races are also planned to increase PVA awareness and donor revenues. In the works are Special "Star Sponsorships" which will be available for NASCAR fans and the general public to place a "Star" on the car for a race of your choice for \$100. It will read, "In Honor of..." for any person you want represented. "Virtual Stars" are also available for purchase for \$50 and will be placed on the web site. Portions of the cost of "Stars" are tax deductible as well. Soon this should be up and running at a special web site or linked from the PVA web site at www.pva.org. Part of the agreement is also the full wrapping of the car transport hauler with PVA signage that will be seen by many people as it heads to each race site across the country. Additionally, a VIP race weekend contest will be required with our ultimate goal of expanding our donor base.

What is clear and undebatable concerning our national organization finances, is that our reliance on direct-mail marketing fundraising will continue to be less profitable. We need new revenue streams in today's crowded charity market. This step in sponsoring a NASCAR racer is clearly "thinking outside the box" for us and hopefully will be rewarding. As the program unfolds I'll keep you informed. As always, please let me know if you have any questions.
