President's Report

SCI Move "Off the Table"

I have witnessed a strange but for the moment acceptable, turn of events concerning the movement of the Jefferson Barracks SCI/D unit to new construction at John Cochran Hospital. In a teleconference April 4, 2008, with representatives from Senator Christopher Bond's office,



the VISN 15 Director, the St. Louis VA Medical Center Director, and myself, the VISN 15 Director stated that although there were discussions in the past, there are no current plans to close the existing SCI/D Jefferson Barracks unit and relocate it to new construction at John Cochran. Pleased with that statement, I didn't want to belabor the point by saying I was at that moment looking at a St. Louis VA Medical Center document that used the language "relocation of SCI unit from JB...," and that several VA individuals had acknowledged the plans to move. At the end of the teleconference I had an extremely puzzled look, and if I were able, I would've been scratching my head. I mentioned this bizarre scenario at our April Board of Directors meeting, and received some interesting conjectures on what had occurred. In sum, I think this ill-advised move is for the moment derailed, but we have no guarantees for the future.

PVA Disaster Relief Fund

Members need to be reminded that our national organization has a Paralyzed Veterans of America Disaster Relief Fund. Funds may be used for transportation, temporary shelter, food, modifications for accessibility, prosthetic appliances, and medical supplies. Funds will not be provided if other assistance has been provided to pay for the items. Replacement damages are only for the veteran's primary dwelling and there is a \$2500 maximum per individual or family. Applications can be received from our Gateway Chapter office or your local National Service Officer. The initial application should be submitted to your NSO who will forward the application to the chapter for submission to National PVA.

Baseball Tickets/Rides

We did not receive any free Cardinal tickets this year, but purchased some excellent box seats for four games. Three of those games we donated to inpatients. We do have two tickets (at least one wheelchair) for the August 20, 2008 evening Pirates game. Send us a letter postmarked no later than May 31, and we will randomly pick someone for free tickets. And lastly, I really would like to see our van giving members rides on Mondays and Fridays. As mentioned elsewhere in this newsletter, please let us know if we can help you.

And Finally-Healthcare

Although we all enjoy trap shoots, luncheons, and going to the summer games, we must never lose sight of our primary purpose - to ensure our members receive the healthcare they have earned and deserve. If you feel strongly about this issue, you simply must get involved and put your experiences in writing. My voice and the Board's are not enough. In response to my last letter to membership, how many of you actually wrote a letter to your Congressional representatives? If you did, please send us a copy. You have no idea how important these letters are. The Chapter will also, with NSO help, soon begin surveying members' experiences at John Cochran. I urge you take the time to complete those surveys.

THE VA PATIENT ADVOCACY PROGRAM

Our hospital strives to be a customer-centered healthcare facility where all patients and their families are treated professionally and with respect, compassion, understanding and courtesy. If we sometimes don't live up to this expectation, we need to know about such instances and take care of them.

The Patient Advocacy Program was established to ensure that veterans and their families who are served within the VA system get the best care possible. Patient advocates are specially trained VA employees who assist you and your family with any concerns about your hospital stay and outpatient visits. If we don't meet our own standards of excellent care, we want to address your concerns in a convenient and timely manner.

The goal of the program is to resolve questions and complaints. Furthermore, it seeks to classify them based on their nature and to utilize each issue in order to improve how we care for veterans. The program is a crucial aspect of patient satisfaction. It contributes to our efforts to provide world-class customer service. We want you to know that we take your concerns very seriously.

A patient advocate can be reached by phone or in person by outpatients or inpatients or their families. Typically, we are contacted because of an occurrence, whether it be a compliment or question or to report dissatisfaction with service. Our phone numbers are posted throughout both divisions of the Medical Center.

The patient advocate visits SCI patients at JC and JB and talks with them and their families. We generally ask how you are doing, if you wish something done that you forgot to tell your provider or if you just want to talk. Staff in the SCI Service knows how to contact us. We will come to see you as soon a possible to help in many different ways.

LAWMAKERS URGE EASING OF INCOME RESTRICTIONS FOR VETERAN HEALTH BENEFITS

A coalition of lawmakers is urging the Department of Veterans Affairs (VA) to drop an "outdated" income restriction and re-open enrollment in the VA health care system to as many as 1.5 million "Priority 8" middle-income veterans who have been denied entry into the system. This Priority 8 group includes vets with no service-connected disabilities who exceed a certain income threshold—currently as low as \$28,430 in some areas. Priority 8 vets were barred from the VA health care system under a 2003 administration directive. The ban was implemented due to cost constraints. But lawmakers seeking the change—including Sen. Daniel K. Akaka, D-Hawaii, chairman of the Senate Veterans Affairs Committee, and Rep. Bob Filner, D-Calif., chairman of the House Veterans Affairs Committee—said that because Congress recently provided VA with the largest funding increase in the department's history, it's time for the ban to be dropped. We have also informed Congress that as many as a million more soldiers currently serving will not enroll when they separate from the Dept. of Defense (DOD). I would encourage everyone to call and write the representatives from Missouri and encourage them to get on board to drop the ban on Cat. 8's. ANNUAL EVALUATIONS AT ST. LOUIS VA SPINAL CORD INJURY CENTER

Our St. Louis Spinal Cord injury Center offers annual evaluations for all of our veterans with spinal cord injuries or disorders that live in our catchment area, which includes Missouri, Kansas, Kentucky, Nebraska and southern Illinois.

Many veterans are unaware that national guidelines call for this comprehensive workup, which can only be completed at one of the 23 SCI Centers in the U.S. It is recommended that it be done as an inpatient, which typically involves a 3-day stay. If that is impossible for an individual, it can be arranged as an outpatient. Please note that by late summer of 2009, we anticipate the availability of a "Fisher House" at our Medical Center, which will allow a patient and/or family to stay for free while receiving medical services.

During the annual evaluation, the veteran will be seen by a SCI board-certified physician, RN, Physical Therapist, Occupational Therapist, Psychologist, Social Worker and Dietitian.

Services provided include the following:

- *physical examination
- *ultrasound to evaluate kidney function
- *immunizations
- *treatment of spasms
- *wheelchair and cushion evaluation
- *review of bowel and bladder needs
- *ordering of any needed durable medical equipment

- *labwork
- *preventive health screenings
- *pain control
- *consultation with other specialists
- *dietary counseling
- *referral to community resources
- *counseling on smoking cessation, substance abuse and sexual concerns

PROCEDURES FOR ADDRESSING ISSUES OR COMPLAINTS AT ALL MEDICAL CENTERS OR CLINICS - By Matt Wilcox (posthumously)

Any time you are admitted into the hospital or just come to a clinic you should be treated professionally. Otherwise, something is wrong! A variety of issues can arise and most are minor. It is sometimes easier to let things pass, but later you wish you had done something. Our concerns are that a few staff constantly violates the rules or that specific areas are troublesome for patients. We would like you to bring these issues to our attention; If not for your own satisfaction, then maybe to stop it from happening again to the next person.

There are ways to address improper care. Some individuals are concerned with possible retribution by just receiving minor attention by staff members if an issue is brought out. We believe this will not be tolerated by the administration! We, as the elected board of the Gateway PVA Chapter, are constantly checking on your care and other issues. There are "Patient Satisfaction Surveys" and if you fill it out, we can document issues and record it with the Chapter. Or you can bring up issues directly to the nurse manager (Jim Weindel) or Mary Ann Jacobs (Nurse Practitioner). Please also notify someone from the Chapter. The majority of issues are resolved at this point. There is also a Patient Care Advocate for SCI/D patients at John Cochran and Jefferson Barracks. If you feel an incident is serious enough, you are free to file a formal complaint with the Advocate or to the PVA Service Officer, Fred Bradley, or your Congressional representatives. In these cases please also notify a board member of the Chapter.

ACCESSIBILITY OF HOTEL ROOM BEDS - By Dennis Durrwachter

Finding a satisfactory wheelchair accessible hotel room can be a challenge. With so many lodging options from which to choose, wheelchair users struggle to find a hotel with the accommodations that best meets their needs. The Americans with Disabilities Act (ADA) has gone a long way to helping us out during our travels outside our homes, but there are still some areas that could be improved, especially when it comes to the person who has to transfer from a wheelchair into and out of a hotel bed.

ADA section 9.2.2(1) addresses one aspect of bedside clearances. It states:

"Where one bed is provided in a room, maneuvering space at least 36 inches wide is required on both sides of the bed. If two beds are provided, this maneuvering space is required only between the beds. Note that the requirement for an accessible route to accessible elements and spaces may result in a 36 inch clearance on the other side of double beds nonetheless."

The 36 inch clearance requirement addressed above comes out of section 305 entitled "Clear Floor or Ground Space." Notice that nowhere in the paragraph is bed height addressed. Also, nothing addresses clearance beneath a bed, however under the bed clearance is a great concern for many quadriplegics who must use a lifting device. Most hoyer lifts require an under the bed clearance of at least 6 inches. A lot of hotel beds are set on box frames with no clearance available. You can request hotel staff to place the box frame on blocks with sufficient clearance for the legs of the lifting device. This is what is often done at hotels hosting the PVA sponsored events. Requesting a separate rollaway bed might also work, but oftentimes is not the most comfortable

Also, too high a bed creates problems trying to manually transfer into the bed from the wheelchair. Why are most hotel beds so high off the floor? Probably because it is easier for most elderly people to get in and out of a higher level bed or may be just because of current styling. On the other side of the coin, for some of us the beds seem too low. Either way, ADA does not regulate furniture. So what can you do other than trying to get ADA changed?

1. Call the hotel directly and ask questions.

Call your preferred hotel and ask about their ADA accessible rooms. Ask whether the beds have open frames or box frame, ask about the height of the bed and ask about other traits of the room such as what type of bath/shower facilities are in the room and how wide the doors are leading into the bathroom. Ask if the beds and other furniture can be moved in order to make the room more comfortable and accessible? Depending on the room size and configuration, you may not need to make any adjustments. Yet, it is a good question to ask particularly if you are unfamiliar with the hotel chain.

2. Listen "in between the lines."

A disabled traveler should be listening for clues that indicate the hotel staff has a good understanding of the difficulties faced by an individual with a disability. If the reservation desk at the wheelchair accessible hotel is knowledgeable about ADA requirements such as passages, counter heights, door hardware, bathroom fixtures, and roll-in showers, there is a good chance the hotel frequently serves disabled guests. However, be wary of hotel representatives that appear to promise too much. If the hotel seems too good to be true... it probably is. Ask to speak to the person's supervisor if you don't get the help you need. Remember as the old saying goes: "An ounce of prevention is worth a pound of cure."


