## DO YOU KNOW WHAT PRIORITY GROUP YOU ARE IN?

All veterans enrolled in the VA health care system are placed in one of eight priority groups, based on a variety of factors.

Details can be found at **va.gov**.

All veterans should know what group they are in to be sure that they are properly categorized, as there are many implications that follow. Veterans with a diagnosis of quadriplegia or paraplegia should be classified as Priority Group 4 (if not 3, 2 or 1). VHA has recognized these diagnoses as "catastrophic disabilities." Congress is considering eliminating co-pays for all veterans in this group, so it is highly recommended that PVA members contact their Social Worker so that if the law is passed, they will be in position to receive medical care with no co-payment responsibilities.

#### President's Report By Stan Brown

#### Planning for John Cochran Replacement Bed Tower with 20 SCI Beds

Almost a year ago I wrote in this column about plans we (Gateway PVA) had discovered to "relocate" the Jefferson Barracks SCI unit to new construction at the John Cochran Hospital complex. In a joint teleconference with the VISN Director and representatives from Senator Bond's office, that in spite of the document I was looking at which



used the words "relocate SCI unit," there were indeed no such plans. At the PVA December 2008 site visit it was casually mentioned that as part of preliminary planning of a new bed tower and improved parking at John Cochran, a ground floor 20 bed SCI unit was also proposed. This was news to both our local chapter and national PVA organization.

It's been almost 3 months of pursuing when and where these plans came from, and who these 20 new SCI beds are designated to serve. I also questioned what role the existing 32 SCI beds at Jefferson Barracks will serve after the John Cochran expansion. Our Gateway Board received a presentation from the departing St. Louis VA Medical Center Director on the preliminary planning of the John Cochran expansion to include new parking structures and a 20 bed SCI unit. I invited and the Director graciously accepted to come to our meeting; he was open and candid in his responses about this proposed project which is only in the planning stage without any funding approved. The preliminary plans and concepts, with possible construction at least five years away, are indeed troublesome to our Gateway Board. Acute care SCI patients requiring surgery would do their rehabilitation at John Cochran and not return to Jefferson Barracks. The 32 SCI beds at Jefferson Barracks, as well as the new 20 SCI beds at John Cochran, would be a mix of rehabilitation and long-term residency. Newly injured SCI patients could go to either facility. SCI therapies would be provided at both locations.

This entire newsletter is not long enough to provide space to put down all my and our Gateway Board's objections, to this concept or preliminary plan. During our evening Board meeting on April 14, 2008, the Board unanimously passed a resolution opposing any plan to have rehabilitative or long-term residency SCI beds on the existing or future expanded John Cochran Hospital complex. Succinctly stated, we feel the healthcare of our members demands SCI veterans have their rehabilitation and long-term care done at Jefferson Barracks, and that only absolutely necessary acute care hospital services with the shortest possible inpatient stays, be done at John Cochran Hospital even as it is preliminarily planned for expansion. #### Third and Fourth Quarter 2008 Fiscal Year SHEP Scores

After filing another FOIA request, I've just received the patient satisfaction scores for 125 VA hospitals throughout the United States. The SHEP (Survey of Health Expectancies of Patients) is the only VA approved patient satisfaction survey and tracks satisfaction responses from both inpatient and outpatient veterans. The surveys cover six months (two quarters) and began in fiscal year 2006. For the most recent reporting period (April 2008-September 2008), John Cochran hospital scored "significantly worse than the national average" for inpatient satisfaction in VA hospitals in 29 out of 29 question categories for All Bed Sections, Medicine, and Surgery. It was the **only** out of 125 VA hospitals, to score that poorly in those categories.



#### **Insurance Coverage Explained**

**Question:** As a service connected veteran why does the Department of Veterans Affairs (VA) request that I tell them about health insurance coverage from non-VA sources?



Answer: The VA requests to know about veterans' private insurance coverage because by Federal law they may bill the insurance company for treatment provided for disabilities or conditions that have not been adjudicated as service connected. When a veteran receives treatment from a VA facility, that treatment must be coded whether or not it is a service connected disability. If it is a service connected disability then the insurance company should not be billed. If it is not a service connected disability then the VA may bill the insurance company. For veterans who are rated 50% or more for service connected disabilities they become eligible for VA treatment of any and all conditions. That status does not cancel the VA's right to bill the private insurance company. For example; if you are service connected for a gastrointestinal condition and you see your VA Primary Care Provider for the renewal for prescriptions for that condition, and at the same time you talk to the VA Primary Care Provider about headaches which are not service connected. The VA may bill your private insurance company for the entire visit because a non-service connected disability was treated.

Even if the VA Primary Care Provider writes into the medical history that the service connected disability is causing or is aggravating a non-service connected disability the insurance company may still be billed. It is not the VA Primary Care Provider's decision that the two conditions were related that determines the billing practice. The VA Regional Office must adjudicate that the non-service connected disability is service connected. At that point in time, the insurance company would not be billed.

If at anytime you believe that the VA is not billing correctly, you may talk to the VA business office or talk to your PVA National Service Officer to help determine if the billing by the VA is indeed appropriate.


