# President's Message By Stanley Brown



## **Gateway PVA honors Vietnam Era members**

At our monthly Jefferson Barracks luncheon, April 21, 2016, we honored and recognized those Gateway members in attendance who had served during the Vietnam War era (November 1, 1955 to May 15, 1975). Gateway has approximately 675 members and we were able to identify 370 of those members as having served during that era. Our Administrative Assistant, Amber Lee, spent hours on identifying the individuals and sending individual letters to each of the 370 members. The letter informed those members of our commemorative ceremony on April 21, 2016 and asked if they were able to attend. We also asked if they would tell us of any awards or declara-



tions they had received. As you might expect, some embellished a little, but many more were too modest. Two of those modest members had received Purple Hearts while "in country" (boots on the ground in Vietnam), and one of those individuals also received a Bronze Star for valor.

We prepared a PowerPoint slide, identifying as best we could from those members who notified us they would attend, each member who had served during the era. It was a tremendous response with members bringing their families. Our luncheon spilled over from the usual lunchroom into all three day rooms. I narrated the PowerPoint presentation and as best I could, tried to explain the lack of welcome and appreciation service members experienced when coming home from Vietnam, as well as the lack of appreciation or respect for those serving stateside during the Vietnam War era. Each individual in attendance was given a commemorative lapel pin and certificate with their name. Our front cover depicts the event. In response to our original mailing, several of you have informed us they would like the pin and certificate mailed to you. If we missed you or you didn't respond, please contact the office.



As best we could tell, three of our members who qualified as having served during the era, came to the luncheon unexpectedly (I'm glad they came), so we didn't have a PowerPoint slide of them. I apologize. One of those individuals is one of my "heroes" and favorite people-James Williams. James was a longtime board member and has been our most winning trapshoot member. James's story could be made into a movie. He entered the Army in 1950 when he was only 15 by giving false information on his age. He quickly found himself in Korea and was shot in the shoulder. When he was about to be discharged because the Army found out his age (16 at that time), he

was able to enlist in the Marines and served there until 1961. In addition to the Purple Heart, James has an Army Commendation Medal and a Combat Infantryman Badge.


### Gateway PVA Accessible Vehicle Grants and Home Generator Grants Now Available

As the fiscal year closes, I believe we have sufficient funds to again disperse the grants to members for generators (\$5,500) and to upgrade or purchase accessible vehicles (\$10,000 or \$35,000). Gateway will pay a vendor directly for a generator for your home, whether portable or permanent. This grant is worth up to \$5,500. Permanent home generators will probably cost more than \$5,500, because of the required additional wiring, gas line upgrade and a new gas meter box. This grant can be awarded regardless of your service connection or your ability to pay for the generator yourself.

Members interested in the generator grant need to submit copies of two bids for a generator in writing either by email, fax, or letter. The \$5,500 amount should cover most portable generators but not a permanent home generator and installation, which may cost up to \$11,000. Gateway will directly pay the vendor of the proposal/bid up to the amount of \$5,500, once the work is completed to the veteran's satisfaction. Please submit your proposal/bids as soon as possible but no later than Thursday, June 30, 2016. Feel free to call Gateway's Executive Director with any questions. We have worked with several contractors on generator installations and can provide company information to facilitate purchase and installation.

Again this year we will have sufficient funding to provide accessible vehicle assistance. Like last year, one grant will be for \$10,000 for a member either with a currently owned accessible vehicle in need of repairs, or trade-in assistance for a vehicle with less miles. A member can trade-in their existing vehicle, receive a credit for that vehicle's value, and then add that value amount to Gateway's \$10,000 grant to purchase an accessible vehicle in better condition. Unlike the past, where Gateway purchased a low mileage accessible vehicle and then gifted it to a member chosen at random, this year we are going to offer a \$35,000 grant for a member to purchase an accessible vehicle of their choice. The grant will be paid directly to the vendor that has the vehicle that the member selects. If the vehicle costs more than the \$35,000, the member will be responsible for the residual amount. In all cases, the member will be responsible for taxes and registration to include inspections, license plates, and insurance. As in the past, members desiring either grant (\$10,000 or \$35,000) will need to submit by email, fax or letter, a statement explaining why assistance is needed in getting the vehicle and the difference it would make in their life. The Gateway Board will consider all requests at their May 10, 2016 Board of Directors meeting. We need the vehicle grant applications by the end of business on Monday, May 9, 2016. Please contact Gateway's Executive Director with any questions.

By the May 10, 2016 Board of Directors meeting, we will have a more complete view of our fiscal year finances, having completed ten months of the fiscal year. At that time we will be able to determine how many accessible vehicle grants we can award. Also as in the past, we will randomly draw names for everyone considered as eligible. Past recipients of vehicle grants should not apply again this year.

# Legal Claim Sharks By Brent Follas



I wanted to raise the attention and awareness of a recent event encountered in my office. A woman that was trying to help her father with VA Benefits first approached a VA Employee. She said she needed a doctor to complete a form. The VA employee asked her what it was for and she said Aid & Attendance. She told the VA Employee she needed to get it back to American Veterans Aid (AVA) so her father could benefit from increased pension due to Aid & Attendance.

The VA Employee brought this woman to my office because he knew we specialized in Special Monthly Compensation. She was unsure if anyone represented her father for prior claims. I found out she was going to be charged \$1450.00 for this service. She was simply trying to have a doctor complete a VA Form 21-2680 "EXAMINATION FOR HOUSEBOUND STATUS OR PERMANENT NEED FOR REGULAR AID AND ATTENDANCE."

She was going to get that form completed and they were going to submit it to the Pension Management Center. I almost fell out of my chair, appalled at what I had just heard. Not only were they going to charge her money for this service, she informed me on how rude they were.

She said they gave her an ultimatum because she was unable to obtain the medical evidence quick enough and they were threatening to end their services if she did not respond.

Luckily, she did not pay anything. I informed her how she could proceed with the claim and gave her all of the contact information she needed to help her father, for free.

I want to raise the awareness that even though these corporations, attorneys and other organization are legal; they charge for their services.

I urge everyone to be aware and to educate anyone they encounter that there are Veteran Service Organizations, like Paralyzed Veterans of America, that provide these services for free. The woman was grateful for the information I provided her and she was saved from paying this outrageous fee.

## Redeem your sports points for entertainment cards!

For those members who have not participated in sports/athletic events this year (June 2015—May 2016) your earned points can be used for other forms of entertainment (such as movies, gift cards, concert tickets, etc., not available to Associate members). This usage will be awarded at \$1 per point earned, up to \$150 annually and only awarded in a non-cash distribution such as gift cards or event tickets (minimum of 25 points). Participation points, if not used on sports or recreation, may be redeemed twice a year for entertainment. A Sports Year begins the day after the BOD (Board of Director) meeting that occurs at least 30 days prior to the start of the NVWG and ends the day of that BOD meeting (May 10, 2016).

May 10, 2016 is the end of the fiscal year for sports points. You have until June 30, 2016 to redeem your points for entertainment cards. You must contact the office and let us know what type of card you would like (i.e, Subway, AMC, etc.). Points will not be redeemed by Visa Gift Cards. Any unused points for FY16 do not carry over to points for FY17.

If you have any questions concerning your sports points total, or any other questions, please contact Chris or Amber at the GPVA office. *Sports points accumulation for FY17 begins May 11, 2016.*
