

President's Message

Gateway Is on a Spending Roll

At the recent April Board of Directors meeting, the Board approved some significant outlays of funds to benefit members. Specifically, we approved awarding two \$35,000 accessible vehicle grants and four \$10,000 vehicle grants. In addition, we approved purchasing Kansas City Chiefs field level season tickets, two accessible seats for the eight season home games and the two preseason games. These are excellent seats on the 40 yard line in the accessible seating area. There are two wheelchair places for each game or room for a folding chair(s). The season tickets cost \$2,443.74. Gateway has also opened up their generator program for applications. The program will close May 31, 2017; applications must be received no later than that date. Members must submit two bids for the eligibility of receiving \$5500 paid directly to the vendor for either a portable or standalone whole house generator. We also continue to award home improvement grants in an amount not to exceed \$10,000. Our final expenditure for Cardinals and Royals baseball tickets was \$13,244.

St. Louis County Housing Opportunities

The St. Louis County Home Improvement Program (HIP) is a federally funded program which provides technical advice and financial assistance to qualified homeowners for a variety of all repairs. The program is administered by the St. Louis County Department of Planning, Office of Community Development. Applicants must be the owner and occupant of the property to be improved. Gross household income must meet the low-moderate income limits. A participant can receive up to \$5000 and will sign a five-year forgivable loan agreement that reduces 20% a year. Applications are taken over the phone at either the Clayton (314-615-8232) or South County office (314-615-4025). Available program funds may vary depending on neighborhoods (73 St. Louis County municipalities). The program is aimed at major system upgrades. Eligibility requires up-to-date mortgages and taxes paid. Healthcare While Traveling

Are you, planning a trip outside of the United States anytime soon? If so, are you service connected? Do you know about the VA's Foreign Medical Program (FMP)?

The FMP is a health benefits program for U.S. veterans who are residing or traveling abroad and have a VA rated service connected condition/disability. VA assumes responsibility of payment for certain necessary health care services associated with treatment for those service connected disabilities or any disability associated with and held to be aggravating a service-connected condition. (Veterans living in Canada are under the jurisdiction of FMP; however, inquiries and claims must be directed to the Foreign Countries Operations in Canada.) Additionally, VA may authorize necessary foreign medical services for any condition of a Veteran participating in the VA Vocational Rehabilitation Program (38 U.S.C. 31).

How do I know if I am eligible for FMP?

The eligibility requirements are different for veterans outside the U.S. than for those within the U.S. VA may authorize foreign medical services for veterans only for a VA rated service connected condition, or a condition associated with and aggravated by a VA rated service connected disability. Disability percentage has no bearing on determining eligibility for FMP.

Should I notify FMP if I am traveling abroad?

Pre-registration for eligible Veterans is not necessary. However, Veterans who are permanently relocating to a country under the FMP Office's jurisdiction are encouraged to notify the FMP Office upon establishing a permanent foreign mailing address (address and telephone number). At that time, arrangements will be made for FMP registration and the mailing of detailed program material. Included in the program material will be an FMP Program Guide which provides detailed information on benefit coverage and limitations, how to select health care providers and claim filing instructions. Veterans who are simply traveling abroad need not bother with notification. However, program information is available upon request. Please use VA Form 10-7959f-1 when registering with FMP.

VA Makes Wait Times Transparent for Veterans

April 12, 2017—The Department of Veterans Affairs (VA) is taking unprecedented steps to increase transparency. Today, VA launched a new Access and Quality Tool that provides Veterans with an easy-to-understand way of accessing patient wait time and quality of care data. This tool not only provides Veterans with more information about VA services, it increases accountability and ensures VA is held to a higher standard.

"Veterans must have access to information that is clear and understandable to make informed decisions about their health care," said Secretary of Veterans Affairs Dr. David J. Shulkin. "No other health-care system in the country releases this type of information on wait times. This allows Veterans to see how VA is performing."

The tool allows Veterans to access the average times patients are waiting to be seen in their local area; how Veterans describe their experiences scheduling primary- and specialty-care appointments at specific VA facilities; timeliness of appointments for care needed right away; and the quality of health care delivered at VA medical centers compared with local private-sector hospitals. The Access and Quality Tool is the most transparent and easy to understand wait time and quality data website in the health-care industry.

"This tool is another example of VA leading the way," said Acting Under Secretary for Health Dr. Poonam Alaigh. "No one in the private sector publishes data this way. This tool will instill a spirit of competition and encourage our medical facilities to proactively address access and quality issues while empowering Veterans to make choices according to what works best for them and their families."

VA will continue to make improvements to this tool based on the feedback it receives from Veterans.

March Atlanta Dive By Chris Blanchard, Executive Director

Since I have been on board with the Gateway Chapter, I have tried to attend every Chapter event that we had on the calendar. I have worn out my shoulders playing wheelchair lacrosse, learned how to play Boccia, gone to Trout Lodge, attended three trivia night fundraisers and the list goes on. But this past March I had the opportunity to try something that was truly new for me. I snor-keled the Atlanta Aquarium with three generations of veterans. I have been an avid reef snor-keler for years, but this was an experience unlike any that I have had before. It started with veterans from almost every branch, some disabled and some not, all of us itching to get into the water. We received a short briefing about the dos and don'ts while in the tank and then when everyone was suited up, we went in the water.

I always forget how quiet it is under water and I am always surprised when all I can hear is my own breathing through a plastic tube. But as we slowly followed the team guide through the water, I started to hear another sound. It was my own heart pounding in my ears as a two-ton, twenty foot whale shark glided under me only a few inches away. This giant animal was so close to me that I could see his eyes and I am certain that he could see mine when he bumped me with his dorsal fin. That was just the beginning, soon giant manta rays were getting close and performing barrel rolls that were hypnotizing to watch. Smaller skates and rays swam by so quickly that they were there and then just gone. I could see black tipped sharks, saw fish, hundreds of smaller fish that were brightly colored and a sea turtle that was larger than I expected. As we made our way through the surface of the water in a large figure eight, it seemed to me that these sea creatures were just as curious about us as we were about them. I have never been so close to such a wide variety of animals and certainly never right next to a whale. To say that I was having one of the best adventures of my life does not come close to describing this experience. When it was over and we were out of the water, there were smiling faces everywhere that I looked. The conversations in the locker room were animated and full of exclamations like "One of those whales hit me with its fin!" and "That was really cool! When are we doing this again?"

So I think that you can tell that this was a remarkable experience for me. It wasn't just being in the salty water with all of those animals, it was also having the opportunity to interact with those veterans that has sold me on going back in November. If you have been considering a trip like this, do it. Kudos to Charley Wright for organizing and leading this adventure.

What is/is not covered under FMP?

Unlike typical health benefit/insurance plans, where the range of benefits is standard among all enrolled beneficiaries/subscribers, FMP benefits are limited to services that are medically necessary to treat a VA-rated, service-connected disability or for a condition that is associated with and held to be aggravating a service-connected disability. Supporting medical documentation is always required. The FMP does not pre-authorize services. A copy of the medical documentation must be submitted to determine if the care was related to a service connected disability. Claims filed under the FMP should be submitted no later than 2 years from the date of services or in the case of inpatient care, within 2 years of discharge date.

Covered benefits include:

Durable medical equipment

Emergency services

Hospitalization

Skilled nursing care

Outpatient services

Physical therapy, when under the direct supervision of a licensed physician

Prescription drugs (including insulin) that are FDA approved

Emergency ambulance services to the nearest medical facility for a VA rated service connected disability

HISA-Home Improvement and Structural Alteration grant (must be preauthorized)

There are a number of exclusions to FMP, so before relocating contact the Health Administration Center in Denver, CO. at 303-331-7950 for help. For more information visit the PC@HAC website at www.va.gov/hac or contact your local PVA NSO for assistance.
