

#### Congressman Russ Carnahan Letter to the VA Secretary

This in no way is meant to be a political endorsement, but Gateway PVA needs to sincerely thank Congressman Carnahan for his efforts on our behalf regarding the problems at the John Cochran VA Medical Center and the VA plans to move our SCI/D unit from Jefferson Barracks to the John Cochran facility. The last paragraph of Congressman Carnahan's October 4, 2010 letter to VA Secretary Shinseki states: "In closing, moving the SCI unit from Jefferson Barracks to John Cochran will negatively affect both veterans and their families. Therefore, I urge you to reconsider plans to move the unit. Thank you for your attention to this matter."



## **Copayments Eliminated for Catastrophically Disabled**

This is a notice to all Spinal Cord Injury patients who are/were paying copayments. The law changed on May 5, 2010 to now exempt you from inpatient, outpatient, and prescription copayments due to catastrophic disability. Some of you have received refunds of payments you made for service on May 5<sup>th</sup> or after. Many of you are still waiting and are still receiving bills. If these bills are for services on or after May 5<sup>th</sup>, please check with me (314-894-6467) or with the SCI Social Workers to ensure that you have been placed in the catastrophic disability category. If you have not been placed in Priority Group IV due to catastrophic disability, call me or the SCI Social Workers so we can start the procedure to get your classification changed.

If you are already classified as catastrophically disabled but are still getting bills, please let us know. We need to address these on a case by case basis. As you know, it takes the wheels of bureaucracy time to turn.

New Conditions for Service Connection for Southwest Asia Service Beginning on August 2, 1990 (includes Iraq) and for Afghanistan on or after September 19, 2001

The following conditions can now be service connected if manifest to a 10% degree or more within 1 year from date of release from active duty:

- Brucellosis
- Camylobacter Jejuni
- Coxiella Burnetti (Q Fever)
- Malaria
- Nontyphoid Salmonella
- Shigella
- West Nile Virus

There is an unlimited presumptive period (meaning the condition can manifest at any point in time after release from active duty) for Visceral Leishmaniasis and Mycobacterium Tuberculosis.

If you do not know what these medical conditions are, then you most likely do not have the disease(s). If you served in Southwest Asian countries or some of the supporting countries, seas, ports or even air space and were ever diagnosed with any of these illnesses, you might be eligible for service connection. And if you know someone who did serve in these areas and had any of these illnesses, they are welcomed to call a PVA National Service Officer for assistance. Our focus is on members and member eligibles, but we will assist any veteran whenever we can.



## **Gateway PVA Expands Benefits for Members**

Additional reimbursement/benefits approved at October 12, 2010 Board Meeting Automobile Adaptive Repairs and Home Accessibility Renovations

- 1. At the October evening board meeting, the board discussed amending a recently approved policy to pay \$800 toward drivers' hand controls for vehicles. The board voted to increase the payment amount to \$1000, if necessary, for steering knobs and break extensions. Non-service connected members should contact the office to see if they qualify for this Gateway PVA grant.
- 2. The board also discussed the financial hardship and difficulty for non-service connected members to pay for their homes being renovated for accessibility. The board approved a \$2500 grant for home accessibility modifications for members whose injury/disease is not service connected. To be considered for this Gateway PVA grant, the non-service connected member must: 1) Have been eligible for and exhausted their HISA (Home Improvement Alternations) grant, or 2) Currently applying for a HISA grant, which will not cover the total expense of the renovation. All payments would be made directly to the vendors and would not overlap or duplicate payments made by other agencies or VA sources. If interested in this Gateway PVA grant, please contact our office. Payments will not be paid retroactively for work already completed.
