



President's Message

VA and Gateway PVA Vehicle and Housing Accessibility Grants

I want to take this opportunity to clarify what grants are available through the VA and Gateway PVA to both modify your vehicle and make your housing accessible. In both areas, you must first apply and exhaust your VA grants and funding before receiving Gateway PVA assistance. To receive funding from the VA or Gateway PVA, you must first get approval from either the VA or Gateway PVA for the modifications. For Gateway PVA grants or funding, you will always need two quotes or bids for any contemplated work. I have detailed below the requirements for both VA and Gateway PVA funding. Please contact your PVA Service Officer with any questions on the VA grants and our office with questions concerning Gateway PVA grants.

VA Vehicle Grants

It is of the utmost importance to contact one of our PVA Service Officers to determine your eligibility for these grants to modify your vehicle. They are absolutely the best source of information in this area. A veteran who has a service-connected condition that causes loss of use of either a hand or a foot, or a combination, would be entitled to vehicle modifications such as lifts, locking mechanisms, lowered floors, and hand controls if they are eligible to drive. Non-service-connected veterans may be eligible for some of these vehicle modifications. Generally, vehicle modifications are covered expenses every four years. In addition to the modifications, there is a one-time grant in the amount of \$20,114.34 for service-connected members to purchase a vehicle that can be made accessible. This grant can only be used one time, regardless of whether the grant amount has increased over time. Service-connected blindness may also qualify for a grant. Again, contact a PVA Service Officer for complete and exact details.

Gateway PVA Vehicle Grants (hand controls)

Non-service connected members, after exhausting any eligible modifications through the VA, **may receive** funding to obtain and have installed hand controls. Members must obtain two bids/quotes from reputable sources to obtain and have installed the necessary equipment for hand controls to drive the vehicle. The bids will be presented at an upcoming Gateway Board of Directors' meeting for approval. We will pay the vendors directly after the work is successfully completed. **Do not** have the work done prior to board approval because you will not be reimbursed after the fact.

VA Home Modification Grants

It is likewise of the utmost importance to contact your PVA Service Officer for the exact and detailed information on these grants. The Home Improvement and Structural Alterations (HISA) grant is available to non-service connected veterans in the amount of \$2,000 and service-connected members in the amount of \$6,800. Detailed questions on the veterans' rating/percentage, and grant used in combination with other VA grants, need to be answered by the PVA Service Officer. In addition, the Specially Adapted Housing (SAH) grant is available to certain service-connected veterans in the current amount of



\$67,555. You do not need to use that entire amount at one time, and if you previously used a portion of that amount, you may be eligible for additional funding for the same house or a new house, up to the \$67,555 amount. I recently used another \$22,000 to adapt a new house. Be advised, this process is arduous and you must begin by contacting the VA representative on these grants (SAH). There is also the Special Housing Adaptation (SHA) grant in the amount of \$13,511 for certain service-connected veterans, with the loss of eyesight in both eyes or the loss of use of both hands, to do further adaptation of their current home. Contact your PVA Service Officer for your eligibility.

Gateway PVA Home Modification Grants

Like the vehicle modification grants, Gateway PVA also provides additional home accessibility grants. Members must first obtain two quotes from reputable contractors for the accessibility work on their home. If one of the quotes is from a family member who is a contractor, that contractor must be accredited by the Better Business Bureau and have a recorded performance bond. The two bids must be obtained and presented to the Gateway Board of Directors for approval **prior to any work being started.** The bids likewise must be for the exact same accessibility work on your home. As of October 14, 2014, the Gateway PVA housing accessibility grant is now up to \$7,500 for non-service connected members and \$5,000 for service-connected members. Funds will be paid directly to the approved contractor after successful completion of the work. This grant is available only after a member has exhausted all other available VA funding.

National Director's Report

I have just returned from the Fall 2014 PVA Board of Directors' meeting (not the same as the Annual Convention) in Dallas. Still with a soft cast on my broken right foot, I was advised not to fly and drove instead (12 hours each way!). It rained for eight hours straight on the way back. When I left Dallas it was 92° and upon my return to St. Louis it was 52°! But enough about me (I'm not vying for the "Joey" award), below are the highlights of the meeting:

Keynote Speaker

The keynote speaker was VA Interim Under Secretary for Health, Carolyn M. Clancy, M.D. She was named to the position July 2, 2014, following all the turmoil in the VA that started with the whistleblower complaints at the Phoenix VA. She is well credentialed and acknowledged the VA's current problems, pledging "change." I was able to ask one question and presented her with the VA staffing problems, in particular the fact that the St. Louis VA has an acting Medical Center Director, acting Deputy Director, and acting Chief of Staff. I pointed out that our own beleaguered Acting SCI Chief, Dr. Park, has been acting in that position for 21 months and has basically been doing the work of two physicians. I commented that I believed the shortage of medical professionals has been negatively impacted by all the press concerning VA problems. Later in the meeting, the PVA acting Government Relations Director informed us that there is an acknowledged 28,000 shortage of medical professionals in the VA system to include 9,000 RNs and 4,000 physicians.

PVA Resolution Highlights

Amendment of Judicial Committee Rules of Practice & Procedure for Complaint Proceedings- This resolution partially passed and partially failed. The ability of an individual PVA member to file a judicial complaint (which may result in expelling a PVA member) was expanded to the PVA Executive Committee as a group, as long as each individual signed the complaint. The resolution was originally submitted allowing the Executive Committee to not be individually responsible for filing the complaint, instead allowing them to file a complaint as "a whole." That portion of the resolution was eliminated.

Judicial Committee Complaint Response Time-I submitted this resolution on behalf of Gateway and it narrowly failed. The resolution proposed that if "exigent circumstances" existed for a respondent (person against whom a complaint had been filed), the amount of time to respond would be up to the Judicial Committee. The resolution was amended with expanded, but still set time limits. My position was and remains that a bed-ridden or hospitalized member may need additional, hard to define, time to respond.

Judicial Committee Neutral Counsel-I also submitted this resolution on behalf of Gateway and it failed by a narrow vote with the passing of a motion to postpone indefinitely. The resolution will not be heard. The resolution proposed that if a PVA attorney was involved in researching or preparing a judicial complaint, or in doing the same for a respondent, that same PVA attorney could not advise the Judicial Committee in the same case. Opponents successfully argued the individual attorney's professional ethics would suffice in conflict areas.

Chapter Hospital Liaison Guidelines-This resolution passed and Hospital Liaison Officers (HLO) are now required to submit to their Field Advisory Committee point of contact, their reports no later than the 15th of the following reporting month.

Site Visit Team Members-I submitted this resolution to add another chapter representative, or a representative from a spoke chapter, be present as a member of the site visit at the hub SCI/D unit. I withdrew the resolution after being assured that a certified HLO from a spoke chapter could participate as a site visit team member.

National PVA Personnel Changes

In conjunction with PVA President Al Kovach, Executive Director Homer Townsend announced PVA would fill their number two staff position at the national office. There was much debate over whether to call the individual position "Chief of Staff" or "Deputy Director." The Deputy Director title was finally agreed upon and Associate Executive Director (AED) for Veterans Benefits, Sherman Gillums, was named to fill the position. PVA is now searching for someone to fill the vacated slot as AED of the Veterans Benefits Department.

Independent Living Services

The VA Vocational Rehabilitation and Employment (VR&E) program offers eligible veterans a wide range of vocational and educational counseling services designed to help them choose and train for a vocation. Assistance may include administering interest and aptitude testing, exploring potential occupations, and researching the availability of jobs in those occupations. Additional services include setting occupational goals, locating appropriate educational and training programs, and finding employment.

What about veterans who have severe disabilities that prevent them from becoming employed? For many of these individuals, the answer may be independent living services.

Created to Assist

The purpose of independent living services is to assist eligible veterans whose ability to function independently in family, community, or employment is limited by the severity of their service-connected disability. When these are coupled with their non service-connected disabilities, the vocational or rehabilitative services **must** be appreciably more extensive than for veterans whose disabilities are less severe.

The goal is to allow individuals to participate in family and community life to the maximum extent possible, as well as to increase the potential to return to work. When total independence is not achievable, the objective is to reduce to a **minimum** the level of dependence on services from others.

Who's Eligible?

Unfortunately, eligibility for independent living services is limited to:

- Service-connected veterans who are eligible for VA VR & E based on a minimum of 20% service-connection
- Active-duty personnel who are hospitalized pending discharge or release from active duty with a disability that will likely be compensable at a rate of 20% or more

Vocational Rehabilitation and Employment (VR & E) services are normally limited to the 12-year period following discharge from military service. However, this timeframe may be extended indefinitely in two situations:

The first is for veterans who have a serious employment handicap (SEH), defined as "a significant impairment of a veteran's ability to prepare for, obtain, or retain employment consistent with such veteran's abilities, aptitudes, and interests." The significant impairment may include restrictions caused by the physical disability itself, deficiencies in education and training, or negative attitudes toward people with disabilities. A veteran determined to have an employment handicap will automatically be considered to have a serious employment handicap under several conditions, including having any individual service-connected disability rated at 50% or greater, or having a neuropsychiatric service-connected disability rated at 30% or greater.

The second situation allowing an extension of services beyond the 12-year period is when an individual's medical condition is so severe that achievement of a vocational goal is not currently feasible, or the extension is necessary to ensure he or she will achieve maximum independence in daily living. One or both of these criteria are met by a number of Paralyzed Veterans of America (PVA) members based on paralysis or the progression of spinal-cord disease, with or without the effects of additional disabilities. The service-connected disability need not be the sole or primary cause of the employment handicap or dependence on the services of others in daily living, but it must materially contribute to it. The service-connected disability's impact must be identifiable, measurable, and/or observable.

Obtaining Services

Consideration for independent living services begins by submitting a VA Form 28-1900, Application for Vocational Rehabilitation. A Vocational Rehabilitation Counselor (VRC) meets with the applicant to conduct a comprehensive evaluation to determine entitlement to services. If an individual is entitled, but employment goals are not currently feasible, an evaluation of his or her independent living needs takes place.

The VRC and veteran create an Individualized Independent Living Plan (IILP). They work together to identify the veteran's needs and determine what services are available to address them.

Veterans may also be referred to a VA-contracted specialized rehabilitation facility or rehabilitation professionals for assistance in designing or implementing an IILP. Input may also be requested from the applicant's family members or medical care team. Services provided in an IILP may include, but are not limited to:

- Counseling
- Diagnostic
- Specialized medical, health, and rehabilitation
- Psychological
- Personal and family adjustment issues
- Independent living skills training
- Attendant care training
- Assistive technology (AT) equipment and training
- Identification of appropriate housing accommodations
- Connection with community-based support services
- Coordination with available federal, state, and local government services
- A monthly allowance when authorized by law
- Assistance in maintaining the newly achieved level of independence

Independent living services may be available for up to 24 months. An extension of up to 6 months may be given when a counseling psychologist and the Vocational Rehabilitation Officer agree this would enable the individual to substantially increase his/her level of independence in daily living.


