ALS Walk

Introduction of New Drug for ALS

I attended the ALS Walk on October 1, 2022 and joined Anthony Vicks group. He is a Member of the Gateway Chapter and he and his family are very active in spreading awareness for ALS. I see him in the KU Medical Center Clinics frequently. His wife, Karen, Father, Mother-in-Law and many of his other family and friends were there. It was a beautiful day at Kauffman Stadium and there were hundreds of signs posted from people that suffer(ed) from ALS. Some I recognized. One was a personal friend and many I represented and helped with their claims along with the survivors.

There was something else mentioned at the Walk about a new drug called Relyvrio (marketed as Albrioza in Canada). Hopefully, soon, the VA will have it on its formulary list. It was mentioned that, because of the Ice Bucket Challenge in 2014, it helped streamline the research and production of this drug due to the extraordinary monetary donations provided from the challenge.

History and Birth of Relyvrio

The U.S. Food and Drug Administration approved Relyvrio (sodium phenylbutyrate/ taurursodiol) to treat patients with amyotrophic lateral sclerosis (ALS), commonly referred to as Lou Gehrig's disease.

"This approval provides another important treatment option for

ALS, a life-threatening disease that currently has no cure," said Billy Dunn, M.D., director of the Office of Neuroscience in the FDA's Center for Drug Evaluation and Research. "The FDA remains committed to facilitating the development of additional ALS treatments." ALS is a rare disease that attacks and kills the nerve cells that control voluntary muscles. Voluntary muscles produce movements such as chewing, walking, breathing, and talking. ALS causes the nerves to lose the ability to activate specific muscles, which causes the muscles to become weak and leads to paralysis. ALS is a progressive disease that continues to get worse over time. Most cases will result in death from respiratory failure, usually within three to five years from when the symptoms first appear. Approximately 5,000 individuals in the United States are diagnosed with ALS annually, and approximately 20,000 Americans are currently living with the disease.

Relyvrio can be taken orally by combining one packet in 8 ounces of room temperature water. It can also be administered through a feeding tube. The recommended dosage for the first three weeks is one packet (3 grams sodium phenylbutyrate and 1-gram taurursodiol) daily. After three weeks, the dosage increases to one packet twice a day. The medication can be taken before a snack/meal.

The efficacy of Relyvrio for the treatment of ALS was demonstrated in a 24-week, multicenter, randomized, double-blind,



placebo-controlled, parallel-group study. In the trial, 137 adult patients with ALS were randomized to receive either Relyvrio or placebo. The patients treated with Relyvrio experienced a slower rate of decline on a clinical assessment of daily functioning compared to those receiving a placebo. Additionally, longer overall survival was observed in a post hoc, long-term analysis of patients who originally received Relyvrio versus those who originally received placebo. The most common adverse reactions experienced with Relyvrio were diarrhea, abdominal pain, nausea and upper respiratory tract infection. Relyvrio contains taurursodiol, a bile acid, which may cause worsening diarrhea in patients with disorders that interfere with bile acid circulation. These patients should consider consulting with a specialist before taking Relyvrio.

The prescribing information includes additional information on risks associated with Relyvrio. The FDA granted this application Priority Review designation.

It also received orphan drug designation, which provides incentives to assist and encourage the development of drugs for rare diseases. The FDA granted the approval of Relyvrio to Amylyx Pharmaceuticals Inc.

In March, the Peripheral and Central Nervous System Drugs Advisory committee concluded that the Amylyx study did not provide

"substantial evidence" that its drug was effective. Then in September, during a rare second meeting to consider a drug, the panel reversed course and voted in favor of approval.

The second vote came after Dr. Billy Dunn, director of the FDA's Office of Neuroscience, encouraged the committee to exercise "flexibility" when considering a drug that might help people facing certain death. A much larger study of Relyvrio, the Phoenix Trial, is under way. But results are more than a year off. A negative result from that study would be a major blow to Amylyx and ALS patients.

"If you've got a drug that's extending life by five months," Rind says, "you ought to be able to show that in a larger

> and Justin Klee, who attended Brown University together.

Klee defends the drug's price, saying it will allow the company to develop even better treatments. "This is not a cure," he says. "We need to keep investing

until we cure ALS."

Klee and Cohen have also promised that Amylyx will re-evaluate its drug based on the results of the Phoenix trial.

"If the Phoenix trial is not successful," Klee says, "we will do what's right for patients, which includes taking the drug voluntarily off the market."

But that the decision would require support from the company's investors, and its board of directors.

National Director Report

During the PVA National Convention in May, the Board of Directors passed a resolution having to do with grants for outdoor recreational activities.

National PVA has set aside \$50,000 to be used by Chapters for outside recreational activities. Grants have a \$2,500 limitation per Chapter grant request. Chapters are limited to two grants per year or until funds run out. Grants are open to all 33 chapters. Chapters have to submit a grant request form. Request is submitted to National PVA Sports and Recreational Staff and the Chapters will be notified within 15 business days of the grant's approval or denial.

The intent of these funds is to get veterans out into their communities and enjoy local parks and recreational areas. It could also be used to engage members who are otherwise not active with the chapter, bring novice participants into a sport, and it could also be used as a recruiting tool for new members.

Fall is here! And since October is Physical Therapy month, the SCI therapy highlight for this newsletter will be our SCI PT programming.

We have a wonderful team of physical therapists on our SCI therapy team.

Amy Ikpeama PT, Katie Helton PT, and Lars Lifrak PTA primarily serve our inpatient SCI veterans for their physical therapy needs. Our veterans on the inpatient unit present with a variety of needs-including new SCI rehabilitation; rehabilitation following other medical issues, such as deconditioning after a medical issue; wound care; or inpatient SCI Annual Evaluation. All inpatients are screened for PT needs upon admission, and PT will create a plan of care to address those needs, which may include the following: bed mobility and transfer training; wheelchair seating and mobility assessment and training; safety assessment and education; skin care assessment and education: strength and endurance training; home exercise program; SCI education; caregiver training.

visits. She works directly with the veteran on the wheeled mobility evaluation, equipment trials, prescription, fitting, and maintenance of wheeled mobility products. Jody also works with many other team members involved in the wheelchair provision process, including: Prosthetics departments, local VAs (when veteran is not in St Louis area), manufacturer reps and VA contracted repair vendors.

Stephanie Albers PTA serves as our SCI Therapy Equipment Manager. She is your goto person for equipment questions, and she will triage your equipment needs and get you moving in the right direction. She serves as our liaison between the many people involved in the VA equipment provision process (same as those outlined in Jody's summary): clinician(s), veteran, local providers, Prosthetics, manufacturer, repair vendors, contracting, to name a few!

Meredith Whitehead PT current serves as the lead for our SCI Outpatient PT program, ALS Interdisciplinary Clinic and Multiple Sclerosis Clinic. She addresses SCI and ALS PT needs on an outpatient basis, which may include the following: transfer training; wheelchair seating and mobility assessment and training; safety assessment and education; skin care assessment and education; strength and endurance training; ambulation assessment and training; home exercise program; SCI education; caregiver training.

I could write a great deal more about the outstanding expertise of our SCI PT team, and I think I will do that in future newsletters to properly highlight the wonderful individuals on our SCI therapy team. Our SCI PT team is truly proud and honored to serve you!
